1. This Notice may be cited as the Fuel and Services Control (Fuel Price) Notice, 2017 and shall come into operation on the 10th February, 2017.

Interpretation

2. In this Notice, unless the context otherwise requires -

“**Lowlands**” include Quthing, Qacha’s Nek and Mount Moorosi;

“**Pump price**” means the cost price of fuel reflected on the fuel pump.
