General Notice No. 699 of 2020

NOTICE UNDER SECTION 4(1) OF THE QUARANTINE ACT 2020

WHEREAS section 4(1) of the Quarantine Act 2020 provides that where the Minister considers that it is necessary and expedient to prevent the introduction and spread in Mauritius of a communicable disease, he shall, by notice published in the Gazette, declare that –

- (a) there is or is likely to be an epidemic of the disease; and
- (b) a quarantine period shall be in force in Mauritius, or part thereof, as from such date as may be specified in the notice.

2. NOW THEREFORE, in view of the fact that it is necessary and expedient to prevent the introduction and spread of COVID-19 in Mauritius, I do hereby declare, by virtue of section 4(1) of the Quarantine Act 2020, that –

- (a) there is an epidemic of COVID-19; and
- (b) a quarantine period shall be in force in Mauritius for the period starting on 12 June 2020 and ending 31 August 2020.

General Notice No. 700 of 2020

ORDER UNDER SECTION 3(1)(a) OF THE QUARANTINE ACT 2020

WHEREAS section 3(1)(a) of the Quarantine Act 2020 provides that during a quarantine period, the Prime Minister may, by Order published in the Gazette, prohibit the entry of aircrafts and ships into Mauritius.

2. NOW THEREFORE, I do hereby prohibit, by virtue of section 3(1)(a) of the Quarantine Act 2020, the entry of aircrafts and ships into Mauritius until 31 August 2020, except for those aircrafts and ships as I may approve.
