PRISONS (DECLARATION OF BALAKA HALFWAY HOUSE AS A PRISON ESTABLISHMENT) ORDER, 2020

IN EXERCISE of the powers conferred by section 3 of the Prisons Act, I, RICHARD CHIMWENDO BANDA, Minister of Homeland Security, make the following Order—

- 1. This Order may be cited as the Prisons (Declaration of Balaka Halfway Citation House as a Prison Establishment) Order, 2020.
- 2. The Balaka Halfway House, owned by Prison Fellowship—Malawi, in Balaka district, is hereby declared a Prison for all the intents and purposes of the Act.

- 3. The Halfway House shall be an offender rehabilitation Centre for the Purpose of the treatment, correction and vocational skills training and development of Halfway convicted prisoners approaching discharge dates.
 - House for Regulatory
- 4. The Management of the Halfway House, selection criteria for Regulatory prisoners to be admitted, welfare, security, discipline and discharge therefrom framework of prisoners shall be regulated by the Act and any other applicable written laws.
- 5. The Halfway House shall be jointly managed by the Malawi Prison Management Service and Prison Fellowship—Malawi under a Public-Private Partnership arrangement arrangement.
- 6. The Schedule to the Establishment of the Prisons Notice is hereby Amendment amended by inserting therein, in the proper alphabetical order, Balaka of Schedule Halfway House.
