SURETYSHIP AMENDMENT ACT, 1971.

# ACT

To amend the law relating to suretyship and other intercessions in respect of debt; and to provide for incidental matters.

(Afrikaans text signed by the State President.)  
(Assented to 4th June, 1971.)

**BE IT ENACTED** by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Abolition of certain rules of law.

1. The rules of law known as the *Senatusconsultum Velleianum* and the *Authentica si qua mulier* shall as from the commencement of this Act cease to have the force of law.

Repeal of laws.

2. The laws specified in the Schedule are hereby repealed to the extent set out in the third column thereof.

Saving.

3. The provisions of this Act shall not apply in relation to a juristic act performed before the commencement thereof.

Application in South-West Africa.

4. This Act shall apply also in the territory of South-West Africa, including the Eastern Caprivi Zipfel.

Short title.

5. This Act shall be called the Suretyship Amendment Act, 1971.

**DAAR WORD BEPAAL** deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Die regsreëls bekend as die *Senatusconsultum Velleianum* en die *Authentica si qua mulier* hou vanaf die inwerkingtreding van hierdie Wet op om regskrag te hê. Afskaffing van sekere regsreëls.
2. Die wette in die Bylae vermeld, word hierby herroep in die mate in die derde kolom daarvan uiteengesit. Herroeping van wette.
3. Die bepalinge van hierdie Wet is nie met betrekking tot 'n regshandeling wat voor die inwerkingtreding daarvan verrig is, van toepassing nie. Voorbehoud.
4. Hierdie Wet is ook van toepassing in die gebied Suidwes-Afrika, met inbegrip van die Oostelike Caprivi Zipfel. Toepassing in Suidwes-Afrika.
5. Hierdie Wet heet die Wysigingswet op Borgstelling, Kort titel. 1971.
