**AFKONDIGING VAN WET VAN NASIONALE VERGADERING**

**PROMULGATION OF ACT OF NATIONAL ASSEMBLY**

Die volgende Wet, wat ingevolge die Proklamasie op die Nasionale Vergadering, 1979 (Proklamasie AG. 21 van 1979), deur die Nasionale Vergadering van Suidwes-Afrika aangeneem en deur die Administrateur-generaal onderteken is, word hierby afgekondig in-gevolge artikel 19 van daardie Proklamasie:—

The following Act, which has been adopted by the National Assembly of South West Africa and signed by the Administrator-General in terms of the National Assembly Proclamation, 1979 (Proclamation AG. 21 of 1979), is hereby published in terms of section 19 of that Proclamation:—

**BOXING AND WRESTLING CONTROL AMEND- Act No. 25, 1980  
MENT ACT, 1980**

*(Afrikaans text signed by the Administrator-General on  
17 December 1980)*

**ACT**

**To amend the Boxing and Wrestling Control Act, 1980, in order to provide for the extension of the powers of the board, for the control of trainers and for other incidental matters.**

BE IT ENACTED by the National Assembly of South West Africa, as follows:—

1. Section 1 of the Boxing and Wrestling Control Act, 1980 (hereinafter referred to as the principal Act), is hereby amended —

Amendment of section 1 of Act 11 of 1980.

(a) by the substitution for the definition of “official” of the following definition:

“(i) ‘official’ means any referee, judge, timekeeper, assistant timekeeper, announcer, ~~second~~, trainer or ringmaster; (i)”; and

(b) by the deletion of the definition of “promotor”.

2. Section 7 of the principal Act is hereby amended —

Amendment of section 7 of Act 11 of 1980.

(a) by the substitution for subparagraph (i) of paragraph (c) of the following subparagraph:

“(i) as a boxer, wrestler or official, to take part in tournaments in the capacity in which he has been so registered and, in the case of an official being a trainer, to train any boxer or wrestler for participation in any tournament; or”;

(b) by the substitution for subparagraph (i) of paragraph (g) of the following subparagraph:

“(i) all agreements entered into between the promoter of the tournament and the boxers, wrestlers or officials who will participate therein;”;

(c) by the substitution for subparagraph (iv) of paragraph (g) of the following subparagraph:

“(iv) a specimen of every proposed advertisement or program relating to the tournament.”;

(d) by die substitution for paragraph (h) of the following paragraph:

“(h) if any agreement between a promoter and a boxer, wrestler or official provides for the payment to such boxer, wrestler or official of a fixed amount as remuneration for his services at or in respect of any proposed tournament, to require the promoter to deposit that amount with the board on or before any specified date prior to the date of the tournament, to be disbursed by the board, subject to the provisions of paragraph (j), in accordance with the agreement, after the tournament has been held, and if any such requirement is not complied with, to cancel any licence which may have been issued under paragraph (j).”.

3. Section 12 of the principal Act is hereby amended by the substitution for paragraph (a) of the following paragraph:

Amendment of section 12 of Act 11 of 1980.

“(a) take part in any tournament as a boxer, wrestler or official or train any boxer or wrestler for participation in any tournament; or”.

4. This Act shall be called the Boxing and Wrestling Control Amendment Act, 1980.
