TYPOGRAPHICAL ERRORS IN THE DESCRIPTION OF ROADS IN PART II OF SCHEDULE II TO PROCLAMATION NO. 22 OF 1929.

It is hereby notified for general information that the following typographical errors appear in the description of roads mentioned in Part II of Schedule II to Proclamation No. 22 of 1929:—

- In district road No. (63): the number "(62)" appearing in the first line should read "(61)".
- In district road No. (64): the number "(63)" appearing in the third line should read "(53)" and at the end of that line the following should be added "to a point where it joins District Road No. (18)".
- In district road No. (66): the number "(62)" appearing in the first line should read "(61)".
- In district road No. (67): the number "(33)" appearing in the last line should read "(79)".
- In district road No. (68): the number "(68)" appearing in the second line should read "(67)".
- In district road No. (72): the number "(25)" appearing in the sixth line should read "(35)".
- In district road No. (83): the number "(84)" appearing in the first line should read "(82)".
- In district road No. (88): the number "(207)" appearing in the third line should read "(217)" and at the end the following should be added "on the farm Okahumba No. 221".
- In district road No. (89): The following should be added at the end of the last line "where it joins District Road No. 33".
- In district road No. (92): the number "(248)" appearing in the fourth line should read "(238)".
- In district road No. (93): the number "(96)" appearing in the first line should read "(92)".
- In district road No. (95): the number "(98)" appearing in the fourth line should read "(94)".
- In district road No. (102): the number "(97)" appearing in the first line should read "(93)".
- In district road No. (107): "District" and "(79)" appearing in the first line should read "Main" and "(2)" respectively and all the words after "158" in the last line to be deleted.

APPOINTMENT OF CLOSE SEASON FOR CRAYFISH (KREEF).

The Administrator has been pleased, under the powers vested in him by section six of the Sealing and Fisheries Proclamation, 1922 (Proclamation No. 18 of 1922), to appoint—

- (a) the period between the first day of January in every year and the fifteenth day of February in the same year (including both days), and
- (b) the period between the sixteenth day of May and the fifteenth day of October (including both days) in every year,

as close seasons, during which the catching of, or the taking of, or any attempt to catch or take, any crayfish (kreef) within the tidal or territorial waters of South West Africa is prohibited.

Government Notice No. 122, dated 4th September, 1929, is hereby cancelled.

- In distrikspad No. (67): behoort die nommer "(33)", wat in die laaste reël verskyn, "(79)" te wees.
- In distrikspad No. (68): behoort die nommer "(68)", wat in die tweede reël verskyn, "(67)" te wees.

VASSTELLING VAN GESLOTE SEISOEN VIR KREEF (CRAYFISH).

Dit het die Administrateur behaag om, kragtens die bevoegdhede aan hom verleen deur artikel ses van "De Robbenvangst en Visserijen Proklamaties 1922" (Proklamasie No. 18 van 1922)—

- (a) die tydperk tussen die eerste dag van Januarie in elke jaar en die vyftiende dag van Februarie in dieselfde jaar (albei dæe ingesluit), en
- (b) die tydperk tussen die sestende dag van Mei en die vyftiende dag van Oktober (albei dæe ingesluit) in elke jaar,

vas te stel as gesloten seisoene, waarin die vangs of neem van kreef (crayfish) of enige poging om dit te vang of te neem binne die gety en territoriale waters van Suidwes-Afrika verbied is.

Ooreenkomsdig onderartikel (2) van artikel dertig van die Dorpe-Ordonnansie 1928 (Ordonnansie No. 11 van 1928) word hierby bekend gemaak, dat dit die voorname is om die Algemene Plan van Windhoek (S.G. No. 709/21) te verander, deur die volgende strate te sluit:

- (1) Die gedeelte van Tiende Laan tussen Park Weg en die suidoostelike baken van Erf No. 133.
- (2) Die gedeelte van Tiende Laan tussen Vierde Straat en Vyfde Straat.
- (3) Vierde Straat.
