3. The terms and conditions for the Credit Guarantee Scheme short-term insurance agreement between a participating institution and the Namibia Special Risks Insurance Association Limited is determined by the Board in terms of section 9(2) of the Namibia Special Risks Insurance Association Act, 2017 (Act No. 5 of 2017).
4. The terms and conditions referred to in paragraph 3, include among others -
- (a) the terms under which the Namibia Special Risks Insurance Association Limited becomes liable to compensate a participating institution for the loss suffered; and
- (b) the percentage of the loss suffered by the participating institution that the Namibia Special Risks Insurance Association Limited guarantees to compensate a participating institution.
