ORDINANCES, 1962: PROMULGATION OF

ORDONNANSIES, 1962: UITVAARDIGING VAN

The Administrator has been pleased to assent, in terms of section *thirty-two* of the South West Africa Constitution Act, 1925 (Act No. 42 of 1925), to the following Ordinances which are hereby published for general information in terms of section *thirty-four* of the said Act:—

ORDINANCE

To prohibit the entry or presence upon land and the entry of or presence in buildings in certain circumstances, and to provide for matters incidental thereto.

(Assented to 28th March, 1962.)

(English Text signed by the Administrator.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. (1) Any person who without the permission —

- (a) of the lawful occupier of any land or any building or part of a building or of a person authorised by or on behalf of such lawful occupier to give permission; or
- (b) of the owner or person in charge of any land or any building or part of a building that is not lawfully occupied by any person,

enters or is upon such land or enters or is in such building or part of a building, shall be guilty of an offence unless he has lawful reason to enter or be upon such land or enter or be in such building or part of a building.

(2) For the purposes of sub-section (1) the expression "lawful occupier" in relation to a building or part of a building does not include a servant of the lawful occupier of the land on which that building is situated.

2. Any person convicted of an offence under section one shall be liable to a fine not exceeding fifty rand or to imprisonment for a period not exceeding three months.

3. The laws set forth in the Schedule are hereby repealed to the extent shown in the third column thereof.

4. This Ordinance shall be called the Trespass Ordinance, 1962.

ORDINANCE

To amend the law relating to game parks, nature parks and private game reserves.

(Assented to 28th March, 1962.)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

No. 3 van 1962.]

ORDONNANSIE

Om die betreding van, of aanwesigheid op, grond en die binnegaan van, of aanwesigheid in, geboue onder sekere omstandighede te verbied en om voorsiening te maak vir verbandhoudende sake.

(Goedgekeur 28 Maart 1962.)

Die Wetgewende Vergadering van die Gebied Suidwes-Afrika VERORDEN:—

1. (1) Iemand wat sonder die toestemming —

- (a) van die wettige okkupeerder van grond of 'n gebou of deel van 'n gebou, of van iemand wat deur of ten behoeve van, sodanige wettige okkupeerder, gemagtig is om toestemming te gee; of
- (b) van die eienaar van, of die persoon wat toesig het oor, grond of 'n gebou of deel van 'n gebou wat nie wettig deur iemand geokkupeer word nie,

sodanige grond betree of daarop is, of sodanige gebou of deel van 'n gebou, binnegaan of daarin is, is aan 'n misdryf skuldig, tensy hy wettige rede het om sodanige grond te betree of daarop te wees, of sodanige gebou of deel van 'n gebou binne te gaan of daarin te wees.

(2) By die toepassing van subartikel (1) sluit die uitdrukking „wettige okkupeerder" met betrekking tot 'n gebou of deel van 'n gebou nie 'n bediende van die wettige okkupeerder van die grond waarop daardie gebou geleë is in nie.

2. Elkeen wat kragtens artikel een aan 'n misdryf skuldig bevind word, is strafbaar met 'n boete van hoogstens vyftig rand of met gevangenisstraf vir 'n tydperk van hoogstens drie maande.

3. Die wette in die Bylae vermeld, word hierby herroep in die mate in die derde kolom daarvan aangedui.

4. Hierdie ordonnansie heet die Ordonnansie op Oortreding 1962.
