ORDINANCE

To amend the Farmers' Special Relief Ordinance, 1959, to grant to the Administrator authority to determine the date up to when application can be made for a loan for concentrates or other fodder or grazing, and to determine the maximum amount of such loan.

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Section 2 of the Farmers Special Relief Ordinance, 1959, (Ordinance 16 of 1959) is hereby amended by the substitution for sub-section (2) of the following subsection:-

> "(2) The Board may subject to the provisions of this ordinance, and from moneys specially voted therefor by the Legislative Assembly, grant to any person to whom the provisions of paragraphs (a) and (b) of sub-section (1) apply, and who has applied therefor on or before a date determined by the Administrator by preclamation and who hy the Administrator by proclamation, and who by reason of his means having been adversely affected by the prevailing donditions of drought, has no reasonable means of buying concentrates or other fodder or hiring grazing for the sustenance of his stock, a loan for the purpose of purchasing such concentrates or other fodder or hiring such grazing; Provided that the Administrator may from time to time determine the maximum amount of such loan."

ORDINANCE

To amend the Administration of Justice Proclamation, 1919.

(Assented to 11th May, 1966) (English text signed by the Administrator)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa, with the consent of the State President in so far as such consent is necessary previously obtained and communicated to the Legislative Assembly by message from the Administrator in accordance with the provisions of section 26 of the South West Africa Constitution Act, 1925 (Act 42 of 1925) of the Republic of South Africa, as follows:-

1. Section 11 of the Administration of Justice Proclamation, 1919 (Proclamation 21 of 1919) is hereby amended by the deletion of sub-section (10).

Amendment of section 11 of Proclamation 21 of 1919 as amended by Proclamation 4 of 1936 and section 13 of Act 74 of 1964,
