ORDONNANSIE, 1968: UITVAARDIGING VAN

ORDINANCE, 1968: PROMULGATION OF

Dit behaag die Administrateur om sy goedkeuring te verleen vir die ooreenkomstige artikel 27 van die Wet op die Konstitusie van Suidwes-Afrika 1968 (Wet 39 van 1968), aan te teken die volgende Ordonnansie wat hierby vir algemene inligting gepubliseer word, ooreenkomstig artikel 29 van die genoemde Wet:—

The Administrator has been pleased to assent, in terms of section 27 of the South West Africa Constitution Act, 1968 (Act 39 of 1968), to the following Ordinance which is hereby published for general information in terms of section 29 of the said Act:—

ORDINANCE

To amend the Town Planning Ordinance, 1954, to provide for a presumption that a local authority mentioned in the third schedule to the ordinance has taken a resolution to prepare a town planning scheme, and for matters incidental thereto.

(Assented to 14th May 1968.)

(Afrikaans text signed by the Administrator)

BE IT ORDAINED by the Legislative Assembly for the Territory of South West Africa as follows:—

1. Section 3 of the Town Planning Ordinance, 1954 — hereinafter called the principal ordinance — is hereby amended by the addition of the following subsection; the existing section becoming subsection (1):—

Amendment of section 3 of Ordinance 18 of 1954.

“(2) For the purposes of this ordinance every local authority mentioned in the third schedule shall be deemed to have taken a formal resolution to prepare a scheme and such resolution shall be deemed to have taken effect.”.

2. Section 16 of the principal ordinance is hereby amended by the substitution in the Afrikaans text of subsection (2) for the words “tree in werking” of the words “word van krag”.

Amendment of section 16 of Ordinance 18 of 1954.

3. Section 39 of the principal ordinance is hereby amended by the substitution in the Afrikaans text of subsection (1) for the words “Waar dit te eniger tyd na die inwerkingtreeding van ’n besluit om ’n skema te ontwerp” of the words “Waar dit te eniger tyd nadat ’n besluit om ’n skema te ontwerp van krag geword het”.

Amendment of section 39 of Ordinance 18 of 1954.

4. Section 40 of the principal ordinance is hereby amended by the substitution in the Afrikaans text for the words „Na die inwerkingtreeding van ’n besluit om ’n skema te ontwerp” of the words “Nadat ’n besluit om ’n skema te ontwerp van krag geword het”.

Amendment of section 40 of Ordinance 18 of 1954.

5. This ordinance shall be called the Town Planning Amendment Ordinance, 1968, and shall be deemed to have come into operation on the date of commencement of the principal ordinance.
