PRICES OF FACTORY MILK.

The Administrator has been pleased under and by virtue of the powers in him vested by paragraph (c) of section *ten* of the Dairy Industry Control Ordinance, 1962 (Ordinance 29 of 1962) — hereinafter referred to as the Ordinance — to approve, with effect from the first day of September, 1965, the prices determined by the Dairy Industry Control Board in terms of the said paragraph (c) for factory milk as set out in the schedule hereto.

Government Notice 116 of the 1st July, 1965 is hereby withdrawn.
