Government Notice 575, dated 28 March 1930, by the substitution for regulation 6 (6) of the following new regulation:

"6. (6) Notwithstanding anything to the contrary contained in these regulations, foods in which sweetening substances are permitted or prescribed by regulation may contain the permitted sweeteners mentioned in subregulation (7). Where artificial sweeteners are used no natural sweeteners shall be added and the name and proportion of the artificial sweetener to the mass or volume of the product, together with the words 'to be used on the advice of a physician' and the words 'contains no added sugar' shall appear on the label.

(7) For the purposes of this Act and subject to the other provisions thereof the following substances are regarded as—

(a) permitted artificial sweeteners:

- (i) Saccharine;
- (ii) saccharine calcium;
- (iii) saccharine sodium;
- (iv) ammonium saccharine;
- (v) calcium cyclamate;
- (vi) sodium cyclamate; and as

(b) permitted natural sweeteners:

Any soluble carbohydrate sweetener (sugar), including sucrose, glucose (or dextrose), fructose (or levulose), maltose and lactose.

Sorbitol may be used in any foodstuff in which sweeteners are allowed on condition that such article contains no other added sugar or artificial sweeteners and that it bears a label with the words 'Sweetened with sorbitol' in letters 3 mm in height."

Interested persons or bodies are invited to submit substantiated comments on this draft amendment to the regulations within three months of the date hereof to the Secretary for Health, Private Bag X88, Pretoria.

AMENDMENT OF REGULATIONS

## MINES, WORKS AND MINERALS ORDINANCE, 1968 (ORDINANCE 20 OF 1968), OF SOUTH-WEST AFRICA

The State President has, in terms of section 95 of the Mines, Works and Minerals Ordinance, 1968 (Ordinance 20 of 1968), of South-West Africa, amended the regulations published under Government Notice 143 of 1 October 1968 in *Official Gazette Extraordinary* 2927 of South-West Africa and as amended by Proclamation R. 89, 1969 of 14 April 1969, as follows:

1. In regulation 20 (1) (c), by the substitution for the words "beacon referred to in regulation 10" of the words "station referred to in regulation 11".

2. In regulation 47 (3), by the substitution for the words—

(a) "holder of a claim or owner of a mining area" of the words "holder of a claim, owner of a mining area or holder of a mining grant in terms of section 61"; and

(b) "claim or mining area" of the words "claim, mining area or grant area referred to in section 61".

3. In regulation 48 (3), by the substitution for the words "claim holder or mining area owner", wherever they occur, of the words "prospector or mine owner".

4. In regulation 256 (1), by the substitution for the words preceding paragraph (a) of the words "(1) No person shall perform, or cause or permit any other person to perform, at any mine or works, any work in connection with the operation of a mine or works, on a Sunday, Christmas Day, Day of the Covenant or Good Friday, or cause any other person to perform, at any mine or works, any such work on Republic Day, unless the work is—".
