**REGULATIONS FOR REGULATING THE REQUIREMENTS IN CONNECTION WITH THE EXPORT OF CANNED PRODUCTS FROM THE REPUBLIC OF SOUTH AFRICA.—AMENDMENT**

The Minister of Agriculture has, under the powers vested in him by section 4 of the Agricultural Produce Export Act, 1971 (No. 51 of 1971), further amended the regulations published by Government Notice R. 1897 of 22 October 1971, as amended, as set out in the Schedule hereto.

**SCHEDULE**

The Schedule to Government Notice R. 1897 of 22 October 1971, as amended, is hereby further amended as follows:

1. Regulation 82 is hereby substituted by the following regulation:

“82. Canned foodstuffs intended for export, shall be submitted for inspection at least 24 hours before such canned foodstuffs are to be exported.”

2. Regulation 85 is hereby amended by the substitution for subregulation (1) thereof of the following subregulation:

“(1) Any person who feels aggrieved as a result of any decision or action taken by an inspector, may appeal against such decision or action by submitting a notice of appeal to an inspector within 30 days after he has been notified of that decision or action and depositing within the said period with such inspector or at any office of the Division of Inspection Services of the Department a deposit of R30: Provided that a separate deposit shall be deposited in respect of each separate consignment or production group, as the case may be, and provided further that, if the notice of appeal and deposit are not submitted and deposited within the prescribed period of 30 days, the appellant shall lose his right of appeal in terms of this regulation.”

REGULATION.—MINERAL HYDROCARBONS IN FOODSTUFFS

It is hereby notified for general information in terms of section 15 (6) of the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act 54 of 1972), that the Minister of Health, in terms of section 15 (1), intends to make the following regulation in substitution for regulation 14bis of the regulations published under Government Notice 575 of 28 March 1930, under the repealed Food, Drugs and Disinfectants Act, 1929 (Act 13 of 1929):

“‘Chewing compound’ means chewing gum and other products of like nature and use;

‘dried fruit’ means prunes, currants, sultanas and raisins;

‘GMP’ means limited by good manufacturing practice; and

‘mineral hydrocarbon’ means any hydrocarbon which is derived from any substance of mineral origin.

Any person shall be guilty of an offence if he sells a foodstuff containing mineral hydrocarbons: Provided that a foodstuff mentioned in column I of Schedule I may contain any mineral hydrocarbon in an amount not exceeding that indicated in the corresponding line of column II of Schedule I, provided that any such mineral hydrocarbon complies with the specifications laid down in Schedule II.”

Interested persons are invited to furnish the Secretary for Health, Private Bag X88, Pretoria, with any comments on, or representations they wish to make in regard to, the proposed regulation within three months of the date of publication of this notice.

(i) the total stand-by allowance received by any employee shall not exceed R36,00 in any month, and

(ii) any employee called out during a stand-by period shall, in addition to the stand-by allowance, be paid overtime according to clause 6 (a) and (b)."

(2) Renumber the existing subclauses (10), (11), (12), (13) and (14) to read (11), (12), (13), (14) and (15) respectively.

**5. CLAUSE 7.—ANNUAL LEAVE**

(1) Substitute the following for subclause (1):

"(1) An employer shall grant to an employee paid leave of not less than three weeks, of which not less than two weeks shall be granted during a period commencing not later than 24 December."

(2) Substitute the following for subclause (2):

"(2) Every employee shall be paid not later than the last working day before the commencement of such leave, leave pay amounting to one-twelfth of the wage he would earn during the period of leave being given, for each completed month of employment with the same employer. In the event of an employee proceeding on less than three consecutive weeks' leave during December, the balance of his leave shall be granted at the employer's discretion during any other time of the year but prior to 30 November of the following year, and the above conditions relating to leave payment shall *mutatis mutandis* apply: Provided that the employer shall have the right to pay an employee who has not taken or been given his full leave in lieu thereof."

**6. CLAUSE 8.—ANNUAL BONUS**

Substitute the following for the table which appears in subclause (1):

8. Insert the following new clause 19:

**"19. CLOSING OF ESTABLISHMENT ON AN ORDINARY WORKING DAY**

(1) Notwithstanding anything to the contrary contained in this Agreement, an establishment may be closed during any period of work specified for that establishment in terms of clause 3, read with clause 6, by mutual agreement between the employer and not less than 75 per cent of his employees, where such an agreement is come to for each specific closing of the establishment.

(2) Whenever an employee is not required to work as a result of the closing of the establishment by mutual agreement in terms of subclause (1), a deduction pro rata for the hours not worked may be made from the amounts payable in terms of this Agreement.

(3) Having regard to the provisions of the Apprenticeship Act, 1944, the provisions of this clause shall not apply to apprentices."

Returns of the determinations and control analyses shall, in terms of regulation 19.2 of the said regulations, be submitted to the Principal Engineer (Mining and Metallurgical Section), Department of Water Affairs, Private Bag X4000, Germiston South, 1411.
