**AMENDMENT OF THE GOVERNMENT
SERVICE ACT, 1980, AND PROVISION FOR
MATTERS CONNECTED THEREWITH**

BYLAE

Wysiging van artikel 1 van Wet 2 van 1980

1. Artikel 1 van die Regeringsdienswet, 1980 (hieronder die Wet genoem), word hierby gewysig deur in paragraaf (b) van die omskrywing van "beampete" in subartikel (1) die woorde "in 'n pos" te skrap.

Wysiging van artikel 2 van Wet 2 van 1980

2. Artikel 2 van die Wet word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang:

"(1) Behoudens die bepalings van subartikel (3), bestaan die regeringsdiens uit die persone wat voltyds, deeltyds, tydelik of onder 'n spesiale kontrak -

- (a) in poste wat deel van die vaste diensstaat uitmaak; of
- (b) addisioneel tot die vaste diensstaat, aangestel is.".

Wysiging van artikel 4 van Wet 2 van 1980

3. Artikel 4 van die Wet word hierby gewysig deur paragraaf (b) van subartikel (13) deur die volgende paragraaf te vervang:

- "(b) wat op die datum van verstryking van sy ampstermyne as Lid van die Kommissie
- (i) nie weer daarin aangestel word nie; of
 - (ii) nie na 'n pos wat deel van die vaste diensstaat uitmaak, oorgeplaas word nie; of
 - (iii) nie addisioneel tot die vaste diensstaat in diens gehou word nie; en".

Under the powers vested in me by Proclamation 181 of 19 August 1977, I hereby make the laws set out in the Schedule.

SCHEDULE

Amendment of section 1 of Act 2 of 1980

1. Section 1 of the Government Service Act, 1980 (hereinafter referred to as the Act), is hereby amended by the deletion in paragraph (b) of the definition of "officer" in subsection (1) of the words "in any post".

Amendment of section 2 of Act 2 of 1980

2. Section 2 of the Act is hereby amended by the substitution for subsection (1) of the following subsection:

"(1) Subject to the provisions of subsection (3), the government service shall consist of all such persons as may be appointed on a full-time or part-time basis or temporarily or under a special contract -

- (a) to posts constituting part of the fixed establishment; or
- (b) additional to the fixed establishment.".

Amendment of section 4 of Act 2 of 1980

3. Section 4 of the Act is hereby amended by the substitution for paragraph (b) of subsection (13) of the following paragraph:

- "(b) who at the date of expiration of his period of office as a member of the Commission -
- (i) is not reappointed thereto; or
 - (ii) is not transferred to a post constituting part of the fixed establishment; or
 - (iii) is not retained in employment additional to the fixed establishment; and".

"(iii) the salary scales, salaries and allowances of teachers occupying posts constituting part of the teaching establishments of government-aided schools in respect of which a subsidy or grant-in-aid is being paid under this Act;

(iv) the discharge and retirement of and termination of service by teachers occupying posts constituting part of the teaching establishments of government-aided schools in respect of which a subsidy or grant-in-aid is being paid under this Act."
