AN ACT to provide for the service of the Republic of Seychelles for the year ending December 31st, 2015.

**ENACTED** by the President and the National Assembly.

1. This Act may be cited as the Appropriation Act, Short title 2015.

## Supplement to Official Gazette [19th January 2015]

Authorisation of expenditure 2. The Minister of Finance, Trade and Investment, may, by warrant under the hand of the Minister, authorise the issue from the Consolidated Fund for the services of the Republic for the year 2015, of a sum not exceeding five thousand nine hundred and thirty seven million and six hundred and forty seven thousand rupees (SCR5,937,647,000) which sum shall be appropriated in accordance with the Schedule for the purposes specified therein.
