EXCISE TAX ACT

(Act 25 of 2009)

Excise Tax (Amendment of Schedule 1) Regulations, 2014

In the exercise of the powers conferred by section 22 of the Excise Tax Act, the Minister of Finance Trade and Investment thereby makes the following Regulations—

1. These Regulations may be cited as the Excise Tax (Amendment of Schedule 1) Regulations, 2014 and shall come into operation on 1st January 2015.

Citation

2. The Excise Tax (Amendment of Schedule 1 and 2) Regulations, 2009, are hereby amended in Schedule 1 as follows—
