# Statistics (Tourism Accommodation Survey) Regulations, 2014

In exercise of the powers conferred by section 24 (a) and (b) of the National Bureau of Statistics Act, 2010, the Minister of Finance, Trade and Investment hereby makes the following regulations—

1. These regulations may be cited as the Statistics (Tourism Accommodation Survey) Regulations, 2014.

Citation

2. In these regulations, unless the context otherwise require—

Interpretation

"Act" means the National Bureau of Statistics (Act 14 of 2010):

"tourism establishments" means a hotel, guesthouse, self-catering establishment, luxury villa or a live-aboard vessel licensed under the Licences (Accommodation, Catering and Entertainment Establishment) Regulations (S.I. 63 of 2011) made under the Licenses Act (Cap 113).

3. The class of persons specified under subregulation (2) shall be liable to furnish to the National Bureau of Statistics for the purposes of the Act, the particulars and information concerning accommodation services or facilities provided by them to tourists.

Class of persons required to submit particulars and

- (2) The class of persons referred to in subregulation (1) are the following tourism establishments—
  - (a) hotels having 25 rooms or more;

- (b) hotels having 24 rooms or less;
- (c) guest houses;
- (d) self-catering establishments;
- (e) luxury villas; and
- (f) live-aboard vessels.

Information to be submitted every month

- 4.(1) The National Bureau of Statistics shall, by notice made under section 15 of the Act, require the tourism establishments to furnish the particulars and information in accordance with these regulations.
- (2) The owner of a tourism establishment shall, on receipt of the notice referred to in subregulation (1), furnish to the National Bureau of Statistics for the purposes of the Act, the particulars and information concerning accommodation services or facilities in the Form set out in the Schedule.
- (3) The owner of a tourism establishment shall furnish the particulars and information by the 10th day of each month in respect of the particulars and information relating to the previous month.
