

**S.I. 58 of 2017**

**ANTI-CORRUPTION ACT**

*(Act 2 of 2016)*

**Anti-Corruption (Term of office, Salary and Allowances of Chairperson, Vice-Chairperson, Commissioners and Chief Executive Officer) Regulations, 2017**

In exercise of the powers conferred by section 85 read with sections 6 (5) and 19 (2) of the Anti-Corruption Act, 2016 the President being Minister for Public Administration hereby makes the following regulations —

1. These Regulations may be cited as the Anti-corruption (Term of office, Salary and Allowances of Chairperson, Vice-Chairperson and Commissioners) Regulations, 2017.

Citation

2. The term of appointment of Chairperson, Vice-Chairperson, Commissioners and the Chief Executive Officer shall be seven years and shall be eligible for reappointment.

Term of appointment

(2) The term of appointment of the Chief Executive Officer shall be three years, and shall be eligible for reappointment.

3.(1) The monthly salary of the Chairperson shall be the sum specified at step 4 of Salary Band 17 of the Public Service Salary Table under the Public Service Salary Act, 2013 (Act 25 of 2013).

Salary of Chairperson

(2) Where the Chairperson is a non-resident Chairperson, he or she shall be eligible for —

(a) full salary when present for attending meetings of the Commission or any other meeting;

- (b) 2/3 of the salary under subregulation (1) when he or she is not present in Seychelles;
- (3) The Chairperson shall be eligible for—
- accommodation allowance at the rate of SCR25,000 per month;
  - a chauffeur driven car when on duty in Seychelles;
  - access to telephone, internet and data facilities in accordance with a signed service agreement, as is applicable for Judges.

4.(1) The monthly salary of the Vice-Chairperson shall be the sum specified at Step 11 of Salary Band 11 of the Public Service Salary Table under the Public Service Salary Act, 2013 (Act 25 of 2013).

(2) The monthly salary of the Commissioners shall be the sum specified at Step 13 of Band 8 of the Public Service Salary Table under the Public Service Salary Act, 2013 (Act 25 of 2013).

5.(1) The monthly salary of the Chief Executive Officer shall be the sum specified at step 10 of Salary Band 15 of the Public Service Salary Table under the Public Service Salary Act, 2013 (Act 25 of 2013).

(2) The Chief Executive Officer shall also be paid—

- transport allowance at SCR5,600 per month;
- a gratuity of 15% of the total salary paid during every calendar year;
- rent-free housing allowance not exceeding SCR25,000 per month.

6 The terms and conditions of employees provided in the Public Service Order shall be applicable to Chairperson, Vice-Chairperson, Commissioners and Chief Executive Officer.
