## EXCISE TAX ACT

(Cap 264)

**Excise Tax (Amendment of Schedule 1) Regulations, 2018**

In the exercise of the powers conferred by Section 22 of the Excise Tax Act, 2009, the Minister of Finance, Trade, Investment and Economic Planning, hereby makes the following Regulations —

1. These Regulations may be cited as the Excise Tax (Amendment of Schedule 1) Regulations, 2018. Citation

2. The Excise Tax (Amendment of Schedule 1 and 2) Regulations, 2009, are hereby amended by repealing Schedule 1 and substituting therefor the following — Amendment of
