PUBLIC UTILITIES CORPORATION ACT

(Cap 196)

Water Supply (Treated Water) (Charges) (Amendment) Regulations, 2018

In exercise of the powers conferred by Section 17 of the Public Utilities Corporation Act, the Minister for Environment, Energy and Climate Change makes the following Regulations—

1. These Regulations may be cited as the Water Supply (Treated Water) (Charges) (Amendment) Regulations, 2018 and shall come into force on 1st September, 2018.

Citation and commencement

2. The Water Supply (Treated Water) (Charges) Regulations are amended by repealing the Schedule and substituting therefor the following Schedule—

2. Surcharge

A surcharge of 2 per cent shall be levied on a compounding basis on an unpaid amount for each period of 30 days or part thereof after an amount is due.

3. Rounding off

In calculating the total monthly charge for water consumed, the total amount shall be rounded off to the nearest 5 cents being above or below, 2 cents being treated as the nearest 5 cents below and 3 or 4 cents being treated as the nearest 5 cents above.

6. Connection for Water Supply—	
(a) to a commercial or government premises where the internal diameter of the service pipe does not exceed 20mm and the length of the service pipe does not exceed 5m.	1580.00

- (a) to premises other than commercial or government premises where the internal diameter of the service pipe does not exceed 20mm and the length of the service pipe does not exceed 5m. 845.00
7. reconnection of water supply —
- (a) to commercial or government Premises or to premises used to supply water to ships (where water supply is disconnected for non-payment) 1053.00
- (b) to any other premises (where water supply is disconnected for non-payment) 150.00
- 8.(1) Where the connection is already connected to a main, the charges for the transfer of connection to another main or to another position on the same main —
- (a) in the case of a connection to a commercial or government premises where the internal diameter of the service pipe does not exceed 20mm and the length of the service pipe does not exceed 5m 790.00
- (b) in the case of a connection to a premises other than commercial or government premises where the internal diameter of the service pipe does not exceed 20mm and the length of the service pipe does not exceed 5m. 422.00

- (c) penalty payable upon disconnection due to any illegal or unauthorised connection 2000.00

In the event of a repetition of the offence the penalty payable shall be double.”
