THE CRIMINAL PROCEDURE (EXTENSION OF JURISDICTION)
ORDER, 2018

Citation 1. This Order may be cited as the Criminal Procedure (Extension of Jurisdiction) Order, 2018.

Investing of extended jurisdiction Cap. 20 2. –(1) The Resident Magistrates whose names are specified in the Schedule to this Order, are, subject to section 173(1) of the Criminal Procedure Act, invested with extended jurisdiction ordinarily exercisable by the High Court.

(2) Consequent upon investing of extended jurisdiction, the persons referred to in subparagraph (1) shall exercise the powers ordinarily exercisable by the Judge of the High Court.

Revocation G.N. No. 514 of 2015 3. The Criminal Procedure (Extension of Jurisdiction) Order, 2015, is hereby revoked.
