ORDER

(Made under sections 6 and 7)

THE VALUE ADDED TAX (EXEMPTION) (CONSTRUCTION OF BOOSTER STATION, TRANSMISSION MAIN, DISTRIBUTION PIPELINES AND STORAGE RESERVOIR FOR KISARAWE WATER SUPPLY PROJECT (M/S CHINA HENAN INTERNATIONAL GROUP (CHICO) ORDER, 2018

Citation and Commencement 1. This Order may be cited as the Value Added Tax (Exemption) (Construction of Booster Station, Transmission Main, Distribution Pipelines and Storage Reservoir for Kisarawe Water Supply Project) (M/S China Henan International Group (CHICO) Order, 2018 and shall be deemed to have come into operation on the 21st day of May, 2018.

GN. No. 663 (Contd)

Exemption

2. Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner, the whole of the Value Added Tax payable on the goods or services specified in the Schedule to this Order imported or purchased prior to clearance through customs or locally purchased by or on behalf of M/S China Henan International Group (CHICO) to be used solely in the Project for Construction of Booster Station, Transmission Main, Distribution Pipelines and Storage Reservoir for Kisarawe Water Supply Project is hereby exempted.

Conditions

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and be payable as if this exemption had not been made if the said goods or services are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.
