Citation and  
Commencement

1. This Order may be cited as the Value Added Tax (Exemption) (For Construction of Dar es Salaam Bus Rapid Transit (BRT) Infrastructure Phase 2 Lot 2 Buildings) (Mbagala Depot, Terminals and Feeder Stations) (M/s China Civil Engineering Construction Corporation (CCECC)) Order, 2018 and shall be deemed to have come into operation on the 13<sup>th</sup> day of August, 2018.

Exemption

2. Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner, the whole of the Value Added Tax payable on the goods or services specified in the Schedule to this Order imported or purchased prior to clearance through customs or locally purchased by or on behalf of M/S China Civil Engineering Construction Corporation to be used solely in the project

Conditions

The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and be payable as if this exemption had not been made if the said goods or services are used for other purposes or sold or disposed of in any way to another person not entitled to enjoy similar privileges as are conferred under this Order.

Expiry

4. This Order shall expire on the 12<sup>th</sup> day of August, 2019.
