(Made Under Section 5 (1))



THE LOCAL GOVERNMENT (URBAN AUTHORITIES) (CONFERMENT OF CITY STATUS ON ILALA MUNICIPAL) ORDER, 2021

WHEREAS, in pursuance of the provisions of section 8(1) of the Local Government (Urban Authorities) Act, Cap. 288, the Minister for the time being responsible for Local Government did give Notice of intention to confer on Ilala Municipal Council the status of a City as specified in that Notice published in the Special Gazette as Government Notice No 1045A. of 22<sup>nd</sup> December 2020;

AND WHEREAS, after the expiry of the period of the Notice, no objections or representations have been received by the Minister such as would justify any delay in conferring the city status.

NOW, THEREFORE, I JOHN POMBE JOSEPH MAGUFULI, President of the United Republic in the exercise of the powers conferred upon me by section 5(1) of the Local Government (Urban Authorities) Act, Cap.288, do hereby make the following Order:-

| Citation                                   | 1. | This Order may be cited as the Local Government (Urban Authorities) (Conferment of City Status on Ilala Municipal) Order, 2021.  |
| Commencement                               | 2. | This Order shall come into operation on the date of publication in the Government Gazette.   |
| Declaration                                | 3. | The urban area under the jurisdiction of the Ilala Municipal Council as described in the First Schedule to this Order is, with effect from the effective date, declared to be a City under the jurisdiction of a City Council. |
| Name of the City Council and Official Seal | 4. | With effect from the effective date, the City Council declared under this Order shall be known as the Dar es Salaam City Council and shall have an Official Seal as described in the Second Schedule to this Order.            |
| Constitution of the Council                | 5. | The Ilala Municipal Council and every member of that Council shall, with effect from the effective date, constitute respectively the Dar es Salaam City Council and member of that Council.                                    |

FIRST SCHEDULE

*(Made under Section.3)*

Commencing at a survey Point T.P.I in the Indian Ocean, the boundary follows a South Westerly direction in a straight-line to Ras Rongoni; thence in the same direction along the coastline to the East ferry point; thence across the ferry to the pier; thence along the coastline South Westerly into Malindi Wharf; thence South Westerly to the main QUAY; thence to the railway sidings,; thence Westerly to the railway line leading to the main Central Railway Line; thence along the Central Railway line to the point where it crosses Nelson Mandela Road; thence Southwards along Nelson Mandela Road to its junction with Nyerere Road; thence Westerly along the centre of Nyerere road dual carriage

way for approximately 1.4 kilometres; thence South ward crossing one of dual carriage way of Nyerere road dual carriage way into the open drainage channel that forms the Western boundary of TAZARA Workshop plot; thence along the open drainage channel to the point it reaches TAZARA Railway line; thence Westerly along TAZARA Railway Line for approximately 5.5 kilometres to the point where Kitunda to Vituka road crosses TAZARA Railway Line; thence Southwards for a distance of 1 hundred metres to join one of Kizinga river tributaries; thence along this tributary to its confluence with Kizinga main river; thence SouthWesterly up stream along Kizinga river for a distance of approximately 10 Kilometres which is before Chasimba Swamps; thence SouthEastwards in a generally straight line for approximately 5 kilometres to meet Mzinga river; thence Southwards for 2<sup>1</sup>/<sub>4</sub> kilometers to meet another Mzinga tributary upstream along this tributary for a distance of 8.2 kilometres to Lumburiani stream; thence South Westerly along Lumburiani stream to Dondwe Pond; thence across Dondwe pond to the Southern boundary of Dondwe prison; thence along Dondwe prison boundary to Taliano Road; thence Southward along Taliano road within Nyasui valley for approximately 8 kilometres to Chanika Homboza road bridge at Zogowali river; thence along Zogowali river to its confluence with Lubelege river; thence along Lubelege river to its source; thence Northeasterly along Kazimzumbwi Forest boundary at approximately 5.0 kilometres to a point where Vikongoro river crosses Kazimzumbwi forest Reserve boundary; thence along the Kazimzumbwi forest Reserve Eastern boundary in a generally straight line North Eastwards to a point where Nyamaronda river crosses Pugu Forest Reserves boundary; thence along the Pugu Forest Reserve on the Eastern side to a survey mark. TP 17 at an altitude of 291 metres above sea level (871ft); thence Northwards to a point 1.6 kilometres; thence due East to the turning point of Kinyerezi and Pugu ward boundaries; thence following Kimara/Kinyerezi ward boundaries to the source of Luhanga River; thence downstream the Luhanga river to its confluence with Msimbazi River; thence down stream along the Msimbazi River to the Salender

Bridge; thence NorthEastwards to a point 3.2 kilometres SouthWest of survey point TP 1; thence NorthEasterly for 3 kilometres to a survey point TP 1 a point of commencement.
