## ORDER

(Made under Section 84)

DAR ES SALAAM CITY COUNCIL (DISSOLUTION) ORDER, 2021

WHEREAS by the provisions of Section 84 of the Local Government (Urban Authorities) Act, Cap. 288 the Minister responsible for Local Government is empowered to dissolve any Urban Authority;

NOW THEREFORE, in exercise of the powers conferred upon me by the provisions of Section 84, I, JOHN POMBE JOSEPH MAGUFULI, President of the United Republic, DO HEREBY make the following Order:

- 1. This Order may be cited as the Dar es Salaam City Council (Dissolution) Order, 2021 and shall come into operation on the 24th day of February, 2021 hereinafter referred to as the effective date.
  - 2. That the Dar es Salaam City Council is hereby dissolved.
- 3. That subject to the provisions of Paragraph 5 of this Order, with effect from the effective date:
  - (a) all functions of the dissolved Council shall be transferred to the Ilala Municipal Council which shall have all the powers, privileges and immunities

enjoyed and or exercised by the dissolved Council;

- (b) all assets and liabilities of the dissolved Council shall be dealt with in accordance with the provisions of the Local Government (Urban Authorities) Act, Cap. 288 and other relevant laws.
- 4. That with effect from the effective date, the Dar es Salaam City Council and its employees shall cease to exercise powers and to perform the functions conferred upon it by the Local Government (Urban Authorities) Act, Cap. 288 or any other written law or subsidiary legislation.
- 5. That notwithstanding the dissolution of the Dar es Salaam City Council, any act, matter or thing validly done or omitted to be done by the dissolved Council and every licence, registration or permit lawfully issued, made or granted and still in force on the date of the dissolution shall continue to be in force for the period specified in the licence, registration or permit unless it is sooner lawfully surrendered, forfeited, suspended, revoked or cancelled,
- 6. That any subsidiary legislation made by the dissolved Council and still in force on the date of the dissolution shall continue to be in force and continued to be enforced by the Ilala Municipal Council as if it was made by the Ilala Municipal Council.
