Citation and  
Commencement

1. This Order may be cited as the Value Added Tax (Exemption) (Institutional Support Project for Domestic Resources Mobilization and Natural Resources Governance ISPGG III)(Supply and Installation of Hardware and Software for Tanzania Electronic Single Window System (TESWS) Lot 3) (Supply, Testing and Commissioning of Desktop Personal Computers Uninterrupted Power Supply (UPS) Units and Working Tools (Tanzania Petroleum Development Corporation (TPDC)) Order, 2020 and shall be deemed to have come into operation on the 30<sup>th</sup> day of November, 2020.

Exemption

2. Subject to the conditions specified in paragraph 3 of this Order, and any other conditions as may be specified by the Commissioner, the whole of the Value Added Tax payable on the goods and services specified in the Schedule to this Order imported or purchased prior to clearance through customs or locally purchased by MFI Documents Solution Limited on behalf of Tanzania Petroleum Development Corporation (TPDC)) for the Supply, Testing and Commissioning of Desktop Personal Computers Uninterrupted Power Supply (UPS) Units and Working Tools is hereby exempt.

3. The exemption granted under this Order shall cease to have effect and the Value Added Tax shall become due and payable as if this exemption had not been granted where the said goods and services are used for other purposes, sold or disposed of in any way to another person not entitled to enjoy similar privileges conferred under this Order.

Expiry

4. This Order shall expire on the 4<sup>th</sup> day of April, 2021.
