Interpretation	2. In these Regulations, save where the contex							
	otherwise requires:							
Cap 307	"Act" means the Tanganyika Law Society Act;							
Cap 341	"advocate" shall have the meaning as defined under the							
	Act;							
	"Council" means the Council established under section							
	15 of the Act;							
	"honorary member" means a member appointed as such							
	by the Council pursuant to section 9 of the Act;							
	"junior advocate" means an advocate who has been in							
	legal practice for a period of less than five years							
	counted from the date of admission to the Roll							
	of Advocates in Mainland Tanzania;							
	"non-practising member" means any practitioner or any							
	other person other than an honorary member,							
	who has applied for and has been granted

	"practising member" means an advocate who has a							
	valid practising certificate in Mainland

practice for a period exceeding six years and above counted from the date of admission to the Roll of Advocates in Mainland Tanzania; and "Society" means the Tanganyika Law Society which is also known by its acronym as "TLS" established under section 3 of the Act.

PART II MEMBERSHIP FEES

Membership fees

Cap 307

3.-(1) The Society shall, for the purpose of these Regulations, have the following categories of members:

- (a) practising members;
- (b) non-practising members;
- (c) notary public and commissioner for oath members,
- (d) non-citizen advocates; and
- (e) honorary member.

(2) A member of the Society, other than an honorary member, shall pay annual subscription fees and other fees or contributions in a manner prescribed in the Schedule.

(3) Notwithstanding subparagraph (1), a member who has attained the age of sixty years or above and has practiced for more than twenty years may apply to the Council for exemption from paying the Society's subscription fees.

Consequences for not paying subscription fees 4. A Member of the Society who fails to pay the subscription fees as required under these Regulations-

- (a) shall not be allowed to practice as an Advocate;
- (b) shall be published in the defaulters' list;
- (c) may not be entitled during that period to any of the rights and privileges of membership; or
- (d) may be suspended or expelled from membership.
