ACT

To rationalise the local government laws applicable to the Province of the Free State that became obsolete as a result of the laws that were enacted since 1994; and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Free State, as follows:-

Repeal of legislation

1. The legislation specified in the first column of the Schedule is hereby repealed to the extent indicated in the second column of the Schedule.
