AMENDMENT TO THE PUBLIC ROADS AND MISCELLANEOUS BY-LAWS

The Municipal Manager of the City of Johannesburg Metropolitan Municipality hereby, in terms of section 13 (a) of the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), publishes the amendment to the Public Roads and Miscellaneous By-Laws of the City of Johannesburg Metropolitan Municipality (as published under Notice 832 dated 21 May 2004), as approved by its Council, as set out hereunder.

The Public Roads and Miscellaneous By-Laws of the City of Johannesburg Metropolitan Municipality, are hereby amended by the insertion of the following section 7A after section 7: "Display of Household Clothes and Fabric, etc.

7A No person shall, with the municipal area of the Council, display in any manner to the view of the public, except as an article for sale in a shop window or on a sidewalk, any article of clothing or any household, domestic or other linen or any other fabric (except when used as curtains) from any window or on or from any wall or balcony or veranda fronting on any street or public place."
