**COMMENCEMENT OF THE WESTERN CAPE BIODIVERSITY ACT, 2021 (ACT 6 OF 2021)**

I, Alan Richard Winde, under section 89 of the Western Cape Biodiversity Act, 2021 (Act 6 of 2021), determine that—

- (a) Chapters 1, 2, 3, 4 and 5;
  - (b) Chapter 6, with the exclusion of section 39(1)(b) and Parts 2, 3 and 4 thereof; and
  - (c) Chapter 12, with the exclusion of—
    - (i) section 79;
    - (ii) section 80;
    - (iii) section 88(1), (2) and (3); and
    - (iv) the repeal by section 87 of the following laws to the extent set out in the Schedule:
      - (aa) the Sea Shore Act, 1935 (Act 21 of 1935);
      - (bb) the Mountain Catchment Areas Act, 1970 (Act 63 of 1970);
      - (cc) the Nature Conservation Ordinance, 1974 (Ordinance 19 of 1974);
      - (dd) the Western Cape Nature and Environmental Conservation Ordinance Amendment Act, 1999 (Act 8 of 1999);
      - (ee) the Western Cape Nature Conservation Laws Amendment Act, 2000 (Act 3 of 2000); and
      - (ff) the Western Cape Biosphere Reserves Act, 2011 (Act 6 of 2011),
- of that Act come into operation on 15 November 2022.
