To amend the Magistrates' Courts Act, 1944, so as to increase the civil jurisdiction of magistrates' courts in respect of causes of action; and to provide for matters connected therewith.

> (Afrikaans text signed by the State President.) (Assented to 10 April 1984.)

RE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:-

1. Section 29 of the Magistrates' Courts Act, 1944 (hereinafter Amendment of called the principal Act), is hereby amended-

(a) by the substitution for paragraph (a) of subsection (1) as substituted by of the following paragraph:

"(a) actions in which is claimed the delivery or transfer Act 94 of 1974. of any property, movable or immovable; not exceeding [one thousand five hundred rand] R5 000 in value;'

(b) by the substitution for the proviso to paragraph (b) of subsection (1) of the following proviso:

"Provided that, where the right of occupation of any such premises or land is in dispute between the parties, such right does not exceed [one thousand five hundred rand] R5 000 in clear value to the occupier;";

by the substitution for paragraph (d) of subsection (1) of the following paragraph:

"(d) actions on or arising out of a liquid document or a mortgage bond, where the claim does not exceed [three thousand rand] R10 000;";

(d) by the substitution for paragraph (e) of subsection (1) of the following paragraph:

"(e) actions on or arising out of any credit agreement as defined in section [1 (1) of the Hire-Purchase Act, 1942 (Act No. 36 of 1942)] 1 of the Credit Agreements Act, 1980 (Act No. 75 of 1980), where the claim or the value of the property in dispute does not exceed [three thousand rand] R10 000;"; and

by the substitution for paragraph (f) of subsection (1) of the following paragraph:

actions other than those already mentioned in this section, where the claim or the value of the matter in dispute does not exceed [one thousand five hundred rand] R5 000."
