GAS REGULATOR LEVIES ACT, 2002

(English text signed by the President.) (Assented to 30 December 2002.)

ACT

To provide for the imposition of levies by the National Gas Regulator; and to provide for matters connected therewith.

B^E IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

- (b) have regard to any representation made to it in terms of paragraph (a);
- (c) give the Minister notice in writing of the proposed imposition or variation of levies, or determination of interest, and specify the period for which such imposition, variation or determination is intended to be operational;
- (d) provide the Minister with reasons for the imposition or variation of levies or determination of interest;
- (e) provide the Minister with evidence of consultation with stakeholders or 10 attempts to consult with stakeholders in the gas industry and of the degree of concurrence among such stakeholders with regard to the imposition or variation of the levies or determination of interest.
- (4) The Minister must, with the concurrence of the Minister of Finance, within a period of 60 days after receiving a notice contemplated in subsection (3)(c), give the Gas Regulator written approval or disapproval of the proposed imposition, variation or determination and, in the event of disapproving that imposition, variation or determination, also give reasons for the disapproval thereof.
- (5) After the receipt of the notice as contemplated in subsection (4), the Minister may, with the concurrence of the Minister of Finance, recommend an alternative levy or 20 interest determination.
- (6) The Gas Regulator may impose or vary levies or determine interest under subsection (1) only after the levies or interest has been approved by the Minister with the concurrence of the Minister of Finance.
- (7) The Gas Regulator must publish the notice contemplated in subsection (1) at least 25 30 days before the commencement of that imposition, variation or determination.
- (8) The levies imposed, levies varied or interest determined under subsection (1) must be reviewed annually by the Gas Regulator.

Disposal and management of levies

- **3.** (1) The levies imposed, levies varied and interest determined under section 2(1) 30 form part of the funds of the Gas Regulator.
- (2) The levies and interest collected by the Gas Regulator must be paid into a bank account designated for that purpose by the Gas Regulator and approved by the National Treasury in terms of section 7(2) of the Public Finance Management Act.
- (3) (a) At least six months before the start of the financial year of the Department of Minerals and Energy, or such other period as may be agreed upon between the Minister and the Gas Regulator, the Gas Regulator must submit to the Minister—
 - a budget of estimated revenue and expenditure for the next financial year of the Gas Regulator as required by section 53 of the Public Finance Management Act; and

- (ii) a business plan in the format prescribed under section 54(1) of the Public Finance Management Act, covering the affairs of the Gas Regulator for the following three financial years.
- (b) The budget and business plan contemplated in paragraph (a) must be submitted for the approval of the Minister and the concurrence of the Minister of Finance.

Non-payment of levies

- **4.** (1) Where a levy is not paid by the person contemplated in section 2(2)(b) on the day such levy becomes due and payable, that person is, apart from payment of the levy, liable to interest calculated upon the unpaid amount of the levy from that date, subject to subsections (2) and (3).
- (2) The calculation of interest due and payable to the Gas Regulator must be based on the uniform interest rate contemplated in section 80(1)(b) of the Public Finance Management Act.

- (4) UNgqongqoshe, ngokuvumelana noNgqongqoshe wezeziMali, kumele kuthi 15 esikhathini esiyizinsuku ezingu 60 ethole isaziso esikhonjwe kwisigatshana (3)(c), akhiphele uMlawuli weGesi isamukelo noma ukuchithwa okubhaliwe kwesimiso esicatshangiwe, ukwehlukahlukana noma ukumisa futhi, lapho isimiso, ukwehlukahlukana noma ukumisa kuchithwa, kumele futhi anike izizathu zaloko.
- (5) Ngemuva kokuthola isaziso esikhonjwe kwisigatshana (4), uNgqongqoshe, 20 ngokuvumelana noNgqongqoshe wezeziMali, kumele enze izincomo zolunye uhlobo lwentela noma ukubeka inzalo.
- (6) Umlawuli weGesi angamisa noma ahlukahlukanise izintela noma abeke inzalo ngaphansi kwesigatshana (1) kuphela ngemuva kokuthi izintela noma izinzalo sezamukelwe nguNgqongqoshe ngokuvumelana noNgqongqoshe wezeziMali.
- (7) Umlawuli weGesi kumele akhiphe isaziso esikhonjwe kwisigatshana (1) kusasele Okungenani izinsuku ezingu 30 ngaphambi kokuqalisa kwaleso simiso, ukwehukahlukana noma ukumisa.
- (8) Izintela noma izinzalo ezibekwe ngaphansi kwesigatshana (1) kumele zibuyekezwe minyaka yonke nguMlawuli weGesi. 30

Ukuqedwa kanye nokulawulwa kwezintela

- 3. (1) Izintela ezimisiwe, izintela ezahlukahlukanisiwe kanye nenzalo ebekwe ngaphansi kwesigaba 2(1) kuba yingxenye yezimali zoMlawuli weGesi.
- (2) Izintela kanye nenzalo okuqoqwe nguMlawuli weGesi kumele kukhokhwe kwi akhawunti yebhange uMlawuli wegesi ayibekele loku futhi eyamukelwe wuphiko 35 lazwelonke lwezezimali ngokwesigaba 7(2) soMthetho wokuLawulwa kwezezi Mali zoMphakathi.
- (3) (a) Kumele kuthi okungenani ezinyangeni eziyisithupha ngaphambi kokuqala konyaka wezimali woMnyango wezaMaminerali naMandla, noma leso sikhathi ekuyovumelana ngaso uNgqongqoshe noMlawuli weGesi, uMlawuli weGesi ahambise 40 kuNgqongqoshe—
 - (i) ulwabomali lwesilinganiso sezimali nochithomali konyaka wezimali olandelayo woMlawuli weGesi njengoba kufunwa yisigaba 53 soMthetho wezokuLawulwa kweziMali zoMphakathi; kanye
 - (ii) nohlelo lwebhizinisi olungendlela ebekwe ngaphansi kwesigaba 54(1) so 45
 Mthetho wezokuLawulwa kweziMali zoMphakathi, oluphethe izindaba zoMlawuli weGesi Zeminyaka yezimali emithathu elandelayo.
- (b) Ulwabomali kanye nohlelo lwebhizinisi okukhonjwe kwindima (a) kumele kuhanjiswe ukuthi uNgqongqoshe ayamukele ngokuvumelana noNgqongqoshe wezezi mali.

Ukungakhokhwa kwezintela

- **4.** (1) Lapho umuntu okhonjwe kwisigaba 2(2)(b) engakhokhi intela ngosuku ekumele ayikhokhe ngalo, lowo muntu kumele akhokhe inzalo, ngaphandle kwentela, ebalwa ngemali angayikhokhanga kusukela ngalolosuku, ngokuhambelana nezigatshana (2) no (3).
- (2) Ukubalwa kwenzalo ekumele ikhokhwe kuMlawuli weGesi kumele ihambelane nezinga lenhlawulo elifanayo elikhonjwe kusigaba 80(1)(b) soMthetho wokuLawulwa kweziMali zoMphakathi.

(3) Levies and interest due are deemed to be a debt due to the Gas Regulator and may be recovered by the Gas Regulator by judicial process in any competent court.

Levy imposition to lapse after five years

5. (1) Subject to subsection (2), any levy imposed in terms of section 2(1)(a) lapses five years after the day on which it was introduced.

(2) The Minister must, at least three months but not more than 12 months before the day on which an imposition of a levy contemplated in section 2(1)(a) would otherwise lapse, at the written request of the Gas Regulator and with the concurrence of the Minister of Finance, give the Gas Regulator in writing approval or disapproval of a re-imposition of such levy and, in the event of disapproving the re-imposition, also give 10 reasons for the disapproval thereof.

(3) Before approving a re-imposition contemplated in subsection (2), the Minister must commission a review of the performance of the Gas Regulator as contemplated in section 6.

Assessment of performance of Gas Regulator

6. (1) In this section "performance" in relation to the Gas Regulator means all or any of the following matters:

(a) The efficiency, economy and effectiveness of the Gas Regulator's management of the financial resources at its disposal;

(b) the benefits deriving from the Gas Regulator's work to those who bear the 20 levies and other charges imposed by the Gas Regulator; and

(c) any other matter determined by the Minister in writing and with the concurrence of the Minister of Finance.

(2) The Minister may, after consultation with the Gas Regulator, appoint any person to conduct an assessment of, and report to the Minister and the Minister of Finance on, 25 the performance of the Gas Regulator if the Minister is satisfied that—

(a) there is sufficient concern among stakeholders in the gas industry about the performance of the Gas Regulator to justify an assessment of that performance; or

(b) the performance of the Gas Regulator is inadequate.

(3) (a) Notwithstanding subsection (2), the Minister must commission an assessment of the performance of the Gas Regulator at least once every five years.

(b) The person appointed to conduct the assessment contemplated in paragraph (a) must report to the Minister and the Minister of Finance.

Short title and commencement

7. This Act is called the Gas Regulator Levies Act, 2002, and comes into operation on a date fixed by the President by proclamation in the *Gazette*.

Ukumiswa kwentela kuphelelwa yisikhathi ngemuva kweminyaka emihlanu

- 5. (1) Ngokuhambelana nesigatshana (2), noma iyiphi intela emiswe ngokwesigaba 2(1)(a) iphelelwa yisikhathi ngemuva kweminyaka emihlanu kusukela ngosuku eyamiswa ngalo.
- (2) UNgqongqoshe kumele kuthi okungenani ezinyangeni ezintathu kodwa kungabi ngaphezu kwezinyanga ezingu 12 ngaphambi kosuku okwamiswa ngalo intela ekhonjwe kusigaba 2(1)(a) iphelelwe yisikhathi, ngokucelwa nguMlawuli weGesi ngombhalo kanye nokuvumelana noNgqongqoshe wezeziMali, anike uMlawuli weGesi isamukelo noma ukuchithwa okubhaliwe kokumisa kafuthi lentela futhi, uma kuchithwa ukumiswa kabusha kwentela, anike izizathu zaloko kuchithwa.
- (3) Ngaphambi kokuthi amukele ukumiswa kabusha okukhonjwe kwisigatshana (2), uNgqongqoshe kumele alayele ukubhekwa kokuthi uMlawuli weGesi usebenze kanjani 15 njengoba kukhonjwe kwisigaba 6.

Ukuhlolwa kokusebenza ko Mlawuli weGesi

- 6. (1) Kulesi sigaba "ukusebenza" mayelana noMlawuli weGesi kusho konke noma okunye kwalokhu okulandelayo:
 - (a) Ukugculisa, umnotho kanye nokwanelisa koMlawuli we gesi ekumenenjeni 20 imithombo yezezimali eqondene naye;
 - (b) izinzuzo ezitholwa ku Mlawuli weGesi yilabo abakhokha izintela kanye nokunye ukukhokha okumiswa nguMlawuli weGesi; kanye
 - noma yiluphi olunye udaba olubekwa nguNgqongqoshe ngombhalo ngokuvumelana no Ngqongqoshe wezeziMali. 25
- (2) UNgqongqoshe, ngemuva kokuxhumana noMlawuli weGesi, angaqoka noma ngubani ukuthi ahlole, futhi abike kuNgqongqoshe kanye noNqongqoshe wezeziMali, ukusebenza koMlawuli weGesi uma uNgqongqoshe anelisekile ukuthi-
 - (a) kunokukhathazeka okwanele kulabo ababambe iqhaza embonini yegesi ngokusebenza koMlawuli weGesi okuvuna ukuhlola kwalokhu kusebenza; 30 noma
 - (b) ukusebenza koMlawuli wegesi akuphelele.
- (3) (a) Nakuba kunesigatshana (2), uNgqongqoshe kumele alayele ukuhlolwa kokusebenza koMlawuli weGesi okungenani kanye eminyakeni emihlanu.
- (b) Umuntu oqokwe ukuthi enze ukuhlola okukhonjwe kwindima (a) kumele abike 35 kuNgqongqoshe kanye noNgqongqoshe wezeziMali.

Isihloko esifushane kanye nokuqhubekela phambili

Lo Mthetho ubizwa ngokuthi uMthetho weziNtela zoMlawuli weGesi, ka2002. kanti uqala ukusebenza ngosuku olubekwa ngu Mongameli ngokumemezela kwi Phephandaba lika Hulumeni. 40
