



REQUEST FOR THE ESTABLISHMENT OF STATUTORY MEASURES RELATING TO LEVIES, REGISTRATION, AND RECORDS & RETURNS ON IMPORTED CHICKEN PRODUCTS IN TERMS OF THE MARKETING OF AGRICULTURAL PRODUCTS ACT

It is hereby made known that, in terms of section 10 of the Marketing of Agricultural Products Act, 1996 (Act No.47 of 1996) (MAP Act), that the Minister of Agriculture, Forestry and Fisheries has received a request from the Association of Meat Importers and Exporters (AMIE) for the establishment of statutory measures relating to levies, registration, the keeping of records and rendering of returns. The applicant for the proposed statutory measures is AMIE, an association founded in 1996, which was established due to a need by meat and poultry importers and exporters, for a mouthpiece to speak on their behalf and to look after the interests of its members.

AMIE proposed a statutory levy of 2c/kg (excluding VAT) on imported chicken products. The proposed levy on the different chicken products will be as follows:

Customs Tariff Classification	Product Description	Levy (excluding Vat)
0207.12.10	Mechanically Deboned Meat	2c/kg
0207.12.20	Not cut in pieces, frozen: Carcasses	2c/kg
0207.12.90	Not cut in pieces, frozen: Other	2c/kg

0207.14.20	Cuts and Offal, frozen: Offal	2c/kg
0207.14.90	Cuts and Offal, frozen: Bone-in	2c/kg

On 19 August 2014 the National Agricultural Marketing Council (NAMC) had discussions with AMIE and the South African Poultry Association. Eventually it was decided to adhere to the original request of AMIE, namely to include the function of "Trade Promotions" to be financed with the proposed statutory levy income. Trade promotions will facilitate the import of certain chicken products and where possible, the export of other chicken products. The estimated income from the proposed statutory levies is between R5.1 million (for 2014/15) and R5.9 million (for 2017/18) per year. The proposed statutory levies will finance the following functions, namely –

- Trade promotions;
- Quality control & Consumer assurance;

- Liaison, including consumer education;
- Transformation in the industry;
- Research and development; and
- Administration

The MAP Act stipulates that a statutory levy may not exceed 5% of the price realised for a specific agricultural product at the first point of sale. The maximum of 5% must be based on a guideline price calculated as the average price at the first point of sale over a period not exceeding three years. For the proposed statutory levies, the guideline price is determined as follows:

Chicken products vary significantly in price, depending on the cut. The table below contains average prices per cut, at the first point of sale for the last three years.

The purpose of the statutory measure relating to registration is to compel importers of chicken products to register with the levy administrator. AMIE considers appointing Red Meat Levy Administrator (Pty) Ltd, the administrator of the red meat and pork statutory levies, to administer the proposed statutory levies. The compulsory registration of these importers will ensure that accurate information is obtained and will also assist in the collection of the proposed statutory levies on imported chicken products.

The purpose of the statutory measure relating to records & returns is to compel importers of chicken products to render records and returns to the levy administrator. This is necessary to ensure that continuous, timeous and accurate information relating to imported chicken

products is available to all role-players. Market information is deemed essential for all role-players in order for them to make informed decisions.

The National Agricultural Marketing Council (NAMC) took cognisance that the proposed implementation of statutory measures relating to levies, registration, the keeping of records and the rendering of returns in the poultry industry as requested by AMIE, is consistent with the objectives of the MAP Act. The request is currently being investigated by the NAMC and recommendations in this regard will be made to the Minister in the near future.

Directly affected groups in the poultry industry are kindly requested to submit any comments, regarding the proposed statutory measures, to the NAMC on or before 26 September 2014, to enable the Council to finalise its recommendation to the Minister in this regard.

- Petroleum Pipelines Industry: R 73 605 924 (2014/15: R 68 848 698)

The expenditure budget represents an increase of 2.5% over the expenditure budget for the Energy Regulator for the financial year 2014/15.

In the 2015/16 budget, the levy payable by the licensed generators for the electricity regulation industry will be effectively reduced by a refund of surplus funds to the value of R 5 531 867 and interest and other income of R3 913 808. FINANCIAL INTELLIGENCE CENTRE ACT, ACT NO. 38 OF 2001**

This directive is issued by the Financial Intelligence Centre (the Centre) in terms of section 43A (1) of the Financial Intelligence Centre Act, Act No. 38 of 2001 (the FIC Act).

This directive applies to all accountable and reporting institutions and to other persons who have an obligation to file a report with the Centre in terms of the provisions of the FIC Act.

1. Purpose of the Directive

- 1.1 The Centre issues this directive to all accountable and reporting institutions and all other persons who have an obligation to file reports with the Centre in terms of sections 28, 28A and 29 of the FIC Act.
- 1.2 The principal objective of the Centre is to assist in the identification of the proceeds of unlawful activities and the combating of money laundering activities and the financing of terrorist and related activities (section 3(1) of the FIC Act).
- 1.3 To achieve its objectives the Centre must process, analyse and interpret information disclosed to it, and obtained by it in terms of the FIC Act and retain such information in the manner and for the period as required in the FIC Act (section 4(a) and (d) of the FIC Act).

- 1.4 The Centre obtains information in the form of reports which are filed with it in accordance with the following sections of the FIC Act, as mentioned above:
- Section 28 (cash threshold reporting)
 - Section 28A (terrorist property reporting); and
 - Section 29 (suspicious and unusual transaction reporting).
- 1.5 Where the abovementioned persons/institutions fail to submit these reports to the Centre, intelligence data needed to fulfill its mandate is lost to the Centre.

2 Directive

- 2.1 This directive is effective from date of publication in the Government Gazette.
- 2.2 Where a person/institution becomes aware of a reporting failure to the Centre such person/institution has to mitigate the loss of intelligence data to the Centre in the following manner:
- 2.2.1 Inform the Centre in writing of the reporting failure immediately after becoming aware of such failure. The notification must be sent to the Executive Manager, Compliance and Prevention, Financial Intelligence Centre; and
- 2.2.2 Request an engagement with the Centre to discuss relevant mitigation factors.
- 2.3 The subsequent arrangements for the mitigation of lost intelligence due to the Centre does not imply condonation of the failure to report information to the Centre, nor does it absolve the reporter from its continuing reporting obligations under the FIC Act or prevent enforcement action being taken by the relevant supervisory body.

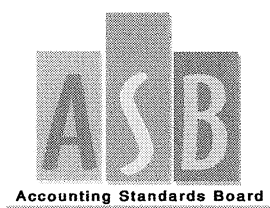

"Category D", in respect of a private consulting practice in natural sciences, shall mean all other salaried technical staff with adequate expertise and relevant experience performing work of a natural scientific nature with direction and control provided by any person contemplated in Categories A or B or C.



SCHEDULE**1. Definition**

In this Schedule, “**the Act**” means the Financial Markets Act, 2012 (Act No. 19 of 2012), and any term, word or expression used in this Schedule, bears the meaning assigned to it in the Act.

2. Governance arrangements

- (1) A market infrastructure must –
 - (a) establish an appropriate and effective internal governance process on potential, perceived or actual conflicts of interest between its regulatory functions and its commercial services;
 - (b) through the established process identify potential, perceived or actual conflicts of interest between its regulatory functions and its commercial services
 - (c) record, adopt and implement, to the satisfaction of the registrar, effective and appropriate policies and measures to address the situation where a potential, perceived or actual conflict of interest is identified to avoid or manage and disclose the conflict; which measures may include-
 - (i) separation of its commercial services from its regulatory functions;
 - (ii) procedures to prevent access to information from employees responsible for either function;
 - (iii) clear guidelines for employees on issues of security and confidentiality .

- (d) constitute an independent committee or other body that is tasked with ensuring that the market infrastructure complies with subparagraphs (a) – (c).;
- (e) take the necessary and appropriate steps to ensure that the committee or body constituted under subparagraph (d) is able to independently fulfil its functions and that it does not labour under a conflicting duty to the management or controlling body of the market infrastructure;
- (f) in its policies, clearly set out the manner in which the market infrastructure will deal with any breaches of the measures under subparagraph (b) and the sanctions and actions that may be taken by the market infrastructure in the event of such breaches.

3. Annual Assessment

- (1) A market infrastructure must –
 - (a) annually assess the efficacy of the policies, processes and measures it has adopted to identify, avoid, eliminate, or otherwise manage and disclose actual or potential conflicts of interest between its regulatory functions and its commercial services;
 - (b) annually prepare a Conflicts of Interest Assessment Report which report must comprehensively deal with the assessment of all material and relevant matters related to the market infrastructure's conflicts of interest policy including
 - (i) an evaluation of the effectiveness of the independent body constituted to deal with conflicts of interest;
 - (ii) whether the controlling body adhered to its conflicts of interest policy;
 - (iii) whether the controlling body effectively implemented and supported the policies and procedures referred to in this Notice;
 - (iv) whether the independent body constituted to deal with conflicts of interest performed a self-evaluation of its performance as well as the performance of the members of this body;
 - (v) whether the market infrastructure identified, disclosed and recorded the conflicts of interest referred to in this Notice; and
 - (vi) whether the market infrastructure adopted appropriate and effective arrangements to separate its regulatory functions from its commercial services;
 - (c) submit its Annual Conflicts of Interest Assessment Report to the registrar together with its Annual Supervisory Assessment Report;
 - (d) publish the results of its Annual Conflicts of Interest Assessment Report at least on its website.
- (2) The independent committee or body referred to in paragraph 2 must perform an annual assessment of its efficiency in enforcing the governance arrangements stated in this section, including an annual review and approval of its terms of reference.
- (3) The assessment referred to in subparagraph (2) may include self-evaluation, a request for feedback from stakeholders and any other form of assessment to measure the efficacy in which the market infrastructure has dealt with any actual or potential conflicts of interest.
- (4) The results of the assessment referred to in subparagraph (2) must be disclosed to the registrar within 5 days of finalisation thereof.

4. Disclosure of conflicts of interest

A market infrastructure must-

- (a) disclose the details of the nature and extent of any conflicts in its annual report contemplated in section 69 of the Act;
- (b) record and publish (at least on its website) all its arrangements in respect of the manner in which it deals with conflicts of interest, including its conflicts of interest's policy.

5. Commencement

The Notice comes into operation on the date of publication.
