MAINTENANCE ACT, 1998

AMENDMENT OF REGULATIONS RELATING TO MAINTENANCE

The Minister for Justice and Constitutional Development has, under section 44 of the Maintenance Act, 1998 (Act No. 99 of 1998), made the regulations in the Schedule.

SCHEDULE

Definitions

1. In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 1361 of 15 November 1999.

Amendment of Regulations

2. The Regulations are hereby amended by the insertion after Chapter 4 of the Regulations of the following chapter:

"CHAPTER 4A

POWERS OF MAINTENANCE INVESTIGATORS

Powers, duties and functions of maintenance investigator

- 23A. (1) A maintenance investigator must have his or her letter of appointment in his or her possession when exercising any power or performing any duty in terms of the Act or these regulations.

(2) A maintenance investigator may, for the purpose of performing his or her functions in terms of the Act –

- (a) examine a person who is likely to give material or relevant information about any complaint relating to maintenance;
- (b) direct a person to identify himself or herself to the satisfaction of the maintenance investigator; and
- (c) request a person to sign for a document, relevant to a complaint relating to maintenance, received from the maintenance investigator.

(3) A maintenance investigator may, for the purpose of service of process of any maintenance court, or service of subpoenas or summonses in respect of criminal proceedings instituted for failure to comply with a maintenance order -

- (a) call upon a member of the South African Police Service as defined in section 1 of the South African Police Act, 1995 (Act No. 68 of 1995), to render assistance to him or her where resistance to the service of the process of the maintenance order or the service of subpoenas and summonses have been met or reasonably anticipated;
- (b) if a maintenance investigator encounters or reasonably anticipates resistance as described in sub paragraph (a), request assistance from the Station Commissioner of the nearest police station and must, upon making such request for assistance, furnish particulars of the complaint in which he or she met resistance or the reason why he or she anticipates resistance.”.

WET OP ONDERHOUD, 1998**WYSIGING VAN DIE REGULASIES BETREFFENDE ONDERHOUD**

Die Minister vir Justisie en Staatkundige Ontwikkeling het ingevolge artikel 44 van die Wet op Onderhoud, 1998 (Wet No. 99 van 1998), die regulasies in die Bylae uitgevaardig.

BYLAE**Woordomskrywing**

1. In hierdie regulasies beteken "die Regulasies" die Regulasies uitgevaardig by Goewermentskennisgewing No. R. 1361 van 15 November 1999.

Invoeging van Hoofstuk 4A in die Regulasies

2. Die volgende hoofstuk word hierby na Hoofstuk 4 van die Regulasies ingevoeg:

"HOOFSTUK 4A**BEVOEGDHEDE VAN ONDERHOUDSONDERSOEKERS****Bevoegdhede, pligte en werksaamhede van onderhoudsondersoeker**

- 23A. (1) 'n Onderhoudsondersoeker moet sy of haar aanstellingsbrief in sy of haar besit hê wanneer enige bevoegdheid uitgeoefen of plig verrig word ingevolge die Wet of hierdie regulasies.

(2) 'n Onderhoudsondersoeker kan, vir die doel van die verrigting van sy of haar werksaamhede ingevolge die Wet –

- (a) 'n persoon ondervra wat waarskynlik wesenlike of tersaaklike inligting oor enige klagte betreffende onderhoud kan verstrek;
- (b) 'n persoon gelas om homself of haarself tot tevredenheid van die onderhoudsondersoeker te identifiseer; en
- (c) 'n persoon versoek om te teken vir 'n dokument, tersaaklik by 'n klagte met betrekking tot onderhoud, wat van die onderhoudsondersoeker ontvang is.


(3) 'n Onderhoudsondersoeker kan, vir die doel van die betekening van prosesstukke van 'n onderhoudshof, of die betekening van getuiedagvaardings of dagvaardings ten opsigte van strafregtelike verrigtinge ingestel vir versuim om aan 'n onderhoudsbevel te voldoen -

- (a) 'n beroep doen op 'n lid van die Suid-Afrikaanse Polisiediens, soos omskryf in artikel 1 van die Wet op die Suid-Afrikaanse Polisiediens, 1995 (Wet No. 68 van 1995), om hulp aan hom of haar te verleen waar teenstand teen die betekening van prosesstukke van die onderhoudsbevel of die betekening van getuiedagvaardings en dagvaardings ondervind word of redelikerwys verwag word;
- (b) indien 'n onderhoudsondersoeker teenstand ondervind of redelikerwys teenstand verwag soos in subparagraaf (a) beskryf, bystand versoek van die Stasiekommissaris van die naaste polisiestasie en moet, by die rig van sodanige versoek om bystand, besonderhede verskaf van die klagte waarin hy of sy teenstand ondervind het of die rede waarom hy of sy teenstand verwag."
