ELECTION OF A SENATOR

I, Nicolaas Diederichs, State President of the Republic of South Africa, hereby determine in terms of the provisions of paragraph 1 (a) of regulation 5 of the regulations for the election of senators in the Territory of South-West Africa, issued under Government Notice R. 1342 of 2 September 1960—

(a) that Monday, 23 August 1976, shall be the day on which a sitting of members of the House of Assembly and of the Legislative Assembly elected for the Territory of South-West Africa shall be held for the purpose of the election of a senator;

(b) that the aforesaid sitting shall commence at 14h30 on the aforesaid day; and

(c) that the Council Chamber of the said Legislative Assembly at Windhoek shall be the place at which the aforesaid sitting shall be held.
