Definitions

1. (a) In these Regulations any meaning assigned to any word or expression in the Act, will have that meaning and, unless the context indicates otherwise—
- (i) **“the Act”** means the *Films and Publications Act, 1996 (Act No. 65 of 1996)*, and all other words and phrases shall have the same meaning as defined in section 1 of the Act;
 - (ii) an **“adult premises”** means a business which distributes and/or exhibits films and/or publications classified as “X18” or “R18” or “F18”;
 - (iii) an **“adult video”** means a film, in any format, classified as “X18” or “R18” in terms of section 18 (4) (a) (ii) or (iii) of the Act;
 - (iv) a **“commercial video”** means a video in any format intended for general distribution and/or exhibition;
 - (v) a **“non-commercial video”** means a video in any format intended for distribution and/or exhibition either to a particular group of persons or under any particular circumstances.
- (b) Any form referred to in these Regulations will be the form as prescribed in the annexures to the English text of these regulations.

PROCEDURES

Complaints against publication

2. (a) A complaint in terms of section 16 (1) of the Act shall be lodged with the Board on **Form FPB 1/C**. In circumstances where Form FPB 1/C is not readily available, a complaint may be submitted, in writing, in which case the following details must be provided:
- (i) Full name and address, including a contact telephone or fax number, of the complainant;
 - (ii) the title of the publication forming the subject of the complaint;
 - (iii) the date and number of the edition or issue of the publication;
 - (iv) the name and address of the publisher;
 - (v) the name and address of the distributor in the Republic; and
 - (vi) a brief statement of the complaint, with reference to page numbers and specific paragraphs or lines.
- (b) An original copy of the publication must be submitted with the complaint. If it is not practical to submit an original copy of the publication, the full address of the place where the publication may be examined by the Board should be specified.

Application for reclassification of publication

3. (a) An application in terms of section 16 (2) of the Act shall be lodged with the Board on **Form FPB 2/P**, with the applicable fee, only after the expiry of two years from the date upon which the classification was first published in the *Gazette*.
- (b) An original copy of the publication shall be submitted with an application for reclassification only where there have been changes to the publication since it was first submitted to the Board, in which case an original copy of the changed version shall be submitted. If it is not practical to submit an original copy of the publication, the full address of the place where the publication may be examined by the Board should be specified.

Submission of films for classification

4. (a) A submission of a film, advertisement or trailer of a film for classification in terms of section 18 of the Act shall be made to the Board on **Form FPB 3/F**, together with the applicable fee.
- (b) Where the film, advertisement or trailer is in a video or disc format, a copy of the video or disc must be submitted with the application.
- (c) Where the film, advertisement or trailer submitted is in a 35 mm format the applicant shall, at her or his own expense, arrange for the screening of the film, advertisement or trailer, at a venue, date and time agreed to by the Board.
- (d) Where a film has been classified under the Act, the person who applied for the classification of that film, shall—
- (i) if it is a video or disc, provide a copy thereof;
 - (ii) if it is not a video or disc but a video or disc version is published in the Republic, provide a copy of such version,
- in the form in which the film was so classified, free of charge, to the Board. Such a copy shall be kept and/or disposed of by the Board at its discretion.

Application for reclassification of a film

5. (a) Any application in terms of section 18 (8) of the Act shall be made to the Board on **Form FPB 4/RF**, together with the applicable fee.

- (b) Where there have been changes to the film since it was last submitted for classification, a copy of the film, in any format, incorporating the changes, must be submitted with the application. In the case of a film in a 35 mm format, arrangements for its screening, at the expense of the applicant, shall be made at a venue, date and time to be agreed upon by the Board.

Appeal to the Review Board

6. (a) An appeal to the Review Board in terms of section 20 (1) of the Act shall be submitted to the Board on **Form FPB 5/RB**, together with the applicable fee, within 30 days from the sooner of either the date on which the appellant was notified of the decision of the Board or such decision was published in the *Gazette*.
- (b) The Review Board may, at its discretion, require that the film, advertisement or trailer, be re-screened at the expense of the applicant unless a copy of the video or disc, or video or disc version of the film, advertisement or trailer, had already been provided to the Board and there have since been no changes to the film, trailer or advertisement.

Application for exemption of persons from certain sections of the Act

7. (a) An application in terms of section 22 (1) of the Act shall be submitted to the Board on **Form FPB 6/EP**. A fee, to be determined by the Board with respect to each application, shall be payable upon the grant of an exemption.
- (b) The applicant shall, at the discretion of the Board, submit any film or publication, intended to be distributed or exhibited by the applicant, for the approval of, or classification by, the Board.

Application for exemption for exhibition of certain films

8. (a) An application in terms of section 23 of the Act shall be submitted to the Board on **Form FPB 7/EF**. A fee, to be determined by the Board with respect to each application, shall be payable upon the grant of an exemption.
- (b) The applicant shall, at the discretion of the Board, submit any film, intended to be distributed or exhibited by the applicant, for the approval of, or classification by, the Board.

Application for registration as a distributor and/or exhibitor

9. (a) An application in terms of section 26 (1) (d) of the Act shall be submitted to the Board on **Form FPB 8/R**, together with the applicable fee. A separate application must be submitted for each branch and/or agency.
- (b) Where applicable in terms of the relevant provisions of the *Business Act, 1991*, the applicant shall submit, together with the application, either a certified copy of a licence, duly issued by a licensing authority, or a certified copy of an application for a licence, in which case a certificate of registration will only be issued upon receipt of a certified copy of the licence duly issued by a licensing authority.

Application for approval to screen films with different classifications at same exhibition

10. (a) An application in terms of section 26 (1) (e) of the Act shall be made to the Chief Executive Officer of the Board on **Form FPB 9/A**.
- (b) The application shall be made not less than 14 days before the date of the exhibition in respect of which the approval is sought.
- (c) A separate application shall be made in respect of each separate combinations of "X18" and other classification category exhibitions.

Application for classification of video wrapper or cover

11. (a) An application for the classification of a video wrapper or cover shall be submitted to the Board on **Form FPB 10/W**, together with the applicable fee.
- (b) A copy of the wrapper or cover, in its original format and colours, must be submitted with the application.

Application for reclassification of a video wrapper or cover

12. (a) An application for the re-classification of a video wrapper or cover shall be submitted to the Board on **Form FPB 11/RW**, together with the applicable fee.
- (b) Where there have been changes to the wrapper or cover originally submitted, a copy of the changed version, in the format and colours of its intended use, must be submitted with the application.

Application for copy of certificate

13. (a) An application for a copy of a certificate of classification, reclassification or registration shall be submitted to the Board on **Form FPB 12/CC**, together with the applicable fee.
- (b) Where the application is in respect of a certificate of registration, a certified copy of a licence duly issued by a licensing authority must be submitted with the application, whether or not a copy thereof had been already submitted with the original application.
- (c) In the case of an application for a copy of a certificate of classification or reclassification, if the applicant is not the person who first submitted the film for classification or reclassification, and in respect of which the application is made, authority or permission from the holder of the original certificate for the issue of a copy of such certificate must be submitted with the application.

Application for review after two years of previous classification

14. (a) An application in terms of section 32 of the Act shall be made on **Form FPB 13/RR**, together with the applicable fee.
- (b) Where the application is in respect of a version different to the version originally previewed and classified—
- (i) in the case of a video in any format, a copy of the changed version must be submitted with the application, and
 - (ii) in the case of a film in a 35 mm format, arrangements for its screening shall be made, at the expense of the applicant at a venue, date and time to be agreed to by the Board.

Application for a copy of the report of the Review Board

15. An application for a copy of a report of the Review Board shall be made to the Board on **Form FPB 14/CRB**, together with the applicable fee.

Application for list of films classified and/or classifications of particular films

16. An application for a list of all films classified by the Board, or the classification categories of particular films, shall be submitted to the Board on **Form FPB 15/L**, together with the applicable fee.

Notification of the approval of a film for exhibition

17. (a) A film which has been approved for exhibition shall contain the following certificate which shall, immediately before the commencement of that film, be clearly visible for a period of at least 20 seconds:

CERTIFICATE OF APPROVAL

has been approved by classification in terms of the *Films and Publications Act, 1996*.

- (b) Immediately prior to the commencement of the exhibition of a film in public, the following certificate shall be exhibited clearly visible for a period of at least 20 seconds on the screen on which the film will be exhibited:

CERTIFICATE OF APPROVAL

It is hereby certified that the films, portions of films and advertisements in film format that will be screened at this exhibition have been approved by classification in terms of the *Films and Publications Act, 1996*.

Short title and commencement

19. These regulations shall be called the **Films and Publications Regulations, 1998**, and shall come into operation on **1 June 1998**.

Woordomskrywing

1. (a) In hierdie Regulasies het 'n woord of uitdrukking waaraan 'n betekenis in die Wet geheg word daardie betekenis en tensy uit die samehang anders blyk beteken—
- “**die Wet**” die *Wet op Films en Publikasies, 1996 (Wet No. 65 van 1996)*;
- “**'n kommersiële video**” 'n video in enige formaat wat bestem is vir algemene verspreiding en/of vertoning;
- “**'n nie-komersiële video**” 'n video in enige formaat wat bestem is vir verspreiding en/of vertoning aan of 'n besondere groep persone of onder besondere omstandighede;
- “**volwasse perseel**” 'n besigheid wat films of publikasies wat as “X18” of “R18” geklassifiseer is, versprei en/of vertoon; en
- “**volwasse video**” 'n film in enige formaat, wat ingevolge artikel 18 (4) (a) (ii) of (iii) van die Wet as “X18” of “R18” geklassifiseer is.
- (b) Enige van hierdie Regulasies in die Afrikaanse teks wat na 'n vorm verwys, moet uitgelei word as verwysend na 'n vorm wat in die Engelse teks van hierdie Regulasies voorgeskryf is.

Besware teen publikasie

2. (a) 'n Beswaar ingevolge artikel 16 (1) van die Wet moet op **VORM FPB 1/C** aan die Raad voorgelê word. In gevalle waar **VORM PFB 1/C** nie geredelik beskikbaar is nie, moet die beswaar skriftelik voorgelê word, in welke geval die volgende besonderhede verstrek word:
- (i) volle naam en adres, insluitende 'n kontaktelefoon- of faksimilee-nommer van die beswaarmaker;
 - (ii) die titel van die publikasie wat die onderwerp van die beswaar is;
 - (iii) die datum en nommer van die druk of uitgawe van die publikasie;
 - (iv) die naam en adres van die uitgewer;
 - (v) die naam en adres van die verspreider in die Republiek; en
 - (vi) 'n kort uiteensetting van die beswaar, met verwysing na die bladsynommers en spesifieke paragrawe of reël.
- (b) 'n Oorspronklike eksemplaar van die publikasie moet saam met die beswaar voorgelê word. Indien dit nie prakties is om 'n oorspronklike eksemplaar voor te lê nie, moet die volledige adres van die plek waar die publikasie deur die Raad ondersoek kan word, verstrek word.

Aansoek om herklassifikasie van publikasie

3. (a) 'n Aansoek ingevolge artikel 16 (2) van die Wet moet op **VORM FPB 2/P** saam met die toepaslike fooi by die Raad ingedien word, maar slegs na die verloop van twee jaar vanaf die datum waarop die klassifikasie vir die eerste keer in die *Staatskoerant* gepubliseer is.
- (b) 'n Oorspronklike eksemplaar van die publikasie moet slegs saam met 'n aansoek om herklassifikasie voorgelê word indien daar veranderings aan die publikasie was nadat dit vir die eerste keer aan die Raad voorgelê is, in welke geval 'n oorspronklike eksemplaar van die veranderde publikasie voorgelê moet word. Indien dit nie prakties is om oorspronklike eksemplaar voor te lê nie, moet die volledige adres van die plek waar die publikasie deur die Raad ondersoek kan word, verstrek word.

Voorlegging van films vir klassifikasie

4. (a) 'n Voorlegging van 'n film, advertensie of voorprent van 'n film vir klassifikasie ingevolge artikel 18 van die Wet moet aan die Raad op **VORM FPB 3/F**, saam met die toepaslike fooi, gedoen word.
- (b) Indien die film, advertensie of voorprent in 'n video- of skyfieformaat is, moet 'n eksemplaar van die video of skyfie saam met die aansoek voorgelê word.
- (c) Indien die film, advertensie of voorprent in 35 mm-formaat voorgelê word, moet die applikant op eie koste reël vir die vertoning van die film, advertensie of voorprent op 'n perseel, datum en tyd waartoe die Raad ingestem het.
- (d) Indien 'n film kragtens die Wet geklassifiseer is, moet die persoon wat om die klassifikasie aansoek gedoen het—
- (i) indien dit 'n video of skyfie is, 'n eksemplaar daarvan; of
- (ii) indien dit nie 'n video of skyfie is nie, maar 'n video- of skyfieweergawe daarvan in die Republiek uitgegee is, 'n eksemplaar daarvan,
- kosteloos, in die vorm waarin die film aldus geklassifiseer is, aan die Raad verskaf. So 'n eksemplaar moet gehou en/of oor beskik word soos wat die Raad goedvind.

Aansoek om herklassifikasie van film

5. (a) Enige aansoek ingevolge artikel 18 (8) van die Wet moet aan die Raad op **VORM FPB 4/RF** saam met die toepaslike fooi, gedoen word.
- (b) Indien daar veranderings aan die film aangebring is sedert dit die laaste keer vir klassifikasie voorgelê is, moet 'n eksemplaar van die film, in enige formaat, waarin die veranderings geïnkorporeer is, saam met die aansoek voorgelê word. In die geval van 'n film in 35 mm-formaat, moet reëlings vir die vertoning daarvan, op die applikant se onkoste, op 'n perseel, datum en plek waartoe die Raad ingestem het, gedoen word.

Appèl na Hersieningsraad

6. (a) 'n Appèl na die Hersieningsraad ingevolge artikel 20 (1) van die Wet moet aan die Raad op **VORM FPB 5/RB**, saam met die toepaslike fooi, voorgelê word, binne 30 dae of eerder van of die datum waarop die applikant van die beslissing van die Raad verwittig is of waarop die beslissing in die *Staatskoerant* gepubliseer is.
- (b) Die Hersieningsraad kan na goeddunke, vereis dat die film, advertensie of voorprent op die kostes van die applikant hervertoen moet word, tensy 'n eksemplaar van die video of skyfie, of video- of skyfieweergawe van die film, advertensie of voorprent, reeds aan die Raad verskaf is en daar sedertdien geen veranderings aan die film, advertensie of voorprent gemaak is nie.

Aansoek om vrystelling deur persone van sekere bepalings van die Wet

7. (a) 'n Aansoek ingevolge artikel 22 (1) van die Wet moet op **VORM FPB 6/EP** aan die Raad voorgelê word. 'n Fooi, deur die Raad ten opsigte van elke aansoek bepaal, is betaalbaar by die toestaan van 'n vrystelling.
- (b) Die applikant moet, na goeddunke van die Raad, enige film of publikasie wat bestem is vir verspreiding of vertoning deur die applikant, vir die goedkeuring of klassifikasie deur die Raad, voorlê.

Aansoek om vrystelling van vertoning van sekere films

8. (a) 'n Aansoek ingevolge artikel 23 van die Wet moet aan die Raad op **VORM FPB 7/EF** voorgelê word. 'n Fooi, deur die Raad ten opsigte van elke aansoek bepaal, is betaalbaar by die toestaan van 'n vrystelling.
- (b) Die applikant moet, na goeddunke van die Raad, enige film wat bestem is vir verspreiding of vertoning deur die applikant, vir goedkeuring of klassifikasie deur Raad, voorgelê word.

Aansoek om registrasie as verspreiding en/of vertoner

9. (a) 'n Aansoek ingevolge artikel 26 (1) (d) van die Wet moet op **VORM FPB 8/R**, saam met die toepaslike fooi aan die Raad voorgelê word. 'n Aparte aansoek moet vir elke tak en/of agentskap voorgelê word.
- (b) Indien van toepassing ingevolge die toepaslike bepalings van die *Wet op Besighede, 1991*, moet die applikant saam met die aansoek, óf 'n gesertifiseerde afskrif van 'n lisensie, behoorlik deur 'n lisensie-owerheid uitgereik, óf 'n gesertifiseerde afskrif van 'n aansoek om 'n lisensie, in welke geval 'n registrasiesertifikaat slegs by ontvangs van 'n gesertifiseerde afskrif van die lisensie wat behoorlik deur die lisensie-owerheid uitgereik is, uitgereik sal word, voorlê.

Aansoek om goedkeuring om films met verskillende klassifikasie by dieselfde vertoning te vertoon

10. (a) 'n Aansoek ingevolge artikel 26 (1) (e) van die Wet moet aan die Hoof Uitvoerende Beampte van die Raad op **VORM FPB 9/A** gemaak word.
- (b) Die aansoek moet nie later nie as 14 dae voor die datum van die vertoning ten opsigte waarvan die goedkeuring verlang word, gemaak word.
- (c) 'n Aparte aansoek moet ten opsigte van elke afsonderlike kombinasies van "X18" en vertonings van ander klassifikasie-kategorieë gemaak word.

Aansoek om klassifikasie van video-omhulsel of bedekking

11. (a) 'n Aansoek om die klassifikasie van 'n video-omhulsel of bedekking moet aan die Raad op **VORM FPB 10/W** saam met die toepaslike fooi, voorgelê word.
- (b) 'n Eksemplaar van die omhulsel of bedekking in sy oorspronklike formaat en kleure moet die aansoek vergesel.

Aansoek om herklassifikasie van 'n video-omhulsel of bedekking

12. (a) 'n Aansoek om die herklassifikasie van 'n video-omhulsel of bedekking moet aan die Raad op **VORM FPB 11/RW** saam met die toepaslike fooi, voorgelê word.

- (b) Indien daar veranderings aan die omhulsel of bedekking is wat oorspronklik voorgelê is, moet 'n eksemplaar van die veranderde weergawe in die formaat en kleure van bestemde gebruik saam met die aansoek voorgelê word.

Aansoek om afskrif van sertifikaat

13. (a) 'n Aansoek om 'n afskrif van 'n sertifikaat van klassifikasie, herklassifikasie of registrasie moet aan die Raad op **VORM FPB 12/CC**, saam met die toepaslike fooi, voorgelê word.
- (b) Indien die aansoek in verband met 'n sertifikaat van registrasie is, moet 'n gesertifiseerde afskrif van 'n lisensie behoorlik deur die lisensie-owerheid uitgereik, die aansoek vergesel, selfs al was 'n eksemplaar daarvan reeds saam met die oorspronklike aansoek voorgelê.
- (c) In die geval van 'n aansoek om 'n afskrif van 'n sertifikaat van klassifikasie of herklassifikasie, moet, waar die applikant nie die persoon is wat die film ten opsigte waarvan die aansoek gedoen word die eerste keer vir klassifikasie of herklassifikasie voorgelê het nie, 'n magtiging of toestemming van die houër van die oorspronklike sertifikaat, vir die uitreiking van die afskrif van die sertifikaat, die aansoek vergesel.

Aansoek om hersiening na twee jaar na vorige klassifikasie

FILMS AND PUBLICATIONS ACT, 1996 (ACT No. 65 of 1996)

REGULATIONS ON FILMS AND PUBLICATIONS (FEES)

The Minister of Home Affairs has, in terms of section 31 (1) (a) of the *Films and Publications Act, 1996 (Act No. 65 of 1996)*, made the regulations in the Schedule.

SCHEDULE

Definitions

1. (a) In these regulations any word or expression to which a meaning has been assigned in the Act or the Regulations, shall have that meaning, and unless the context otherwise indicates—

“the Act” means the *Films and Publications Act, 1996 (Act No. 65 of 1996)*;

“the Regulations” means the *Films and Publications Regulations, 1998*.

- (b) The forms referred to in the Annexure are the forms prescribed in the English text of the Regulations.

Fees

2. The fees that shall be payable in respect of any application, exemption, permit or appeal under this Act, are set out in the Annexure.

Short title

3. These regulations shall be called the **Films and Publications Regulations (Fees), 1998**, and shall come into operation on **1 June 1998**.
