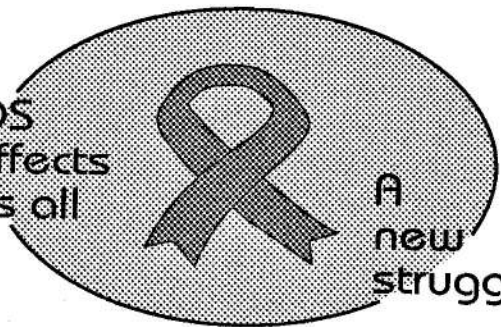

PROCLAMATION*by the**President of the Republic of South Africa***No. R. 44, 2000****COMMENCEMENT OF THE JUSTICE LAWS RATIONALISATION ACT, 1996 (ACT NO. 18 OF 1996)**

Under section 18 of the Justice Laws Rationalisation Act, 1996 (Act No. 18 of 1996), I hereby determine 1 August 2000 as the date on which the Act shall come into operation in so far as it repeals Decree No. 4 (Ombudsman) of 1988 (Decree No. 4 of 1988), applicable in the affected territory of the former Transkei, and the Qwaqwa Ombudsman Act, 1987 (Act No. 6 of 1987), applicable in the affected territory of the former Qwaqwa.
