## PROCLAMATION NOTICE 109 OF 2022

*by the**President of the Republic of South Africa***COMMENCEMENT OF GENERAL LAWS (ANTI-MONEY LAUNDERING AND COMBATING TERRORISM FINANCING) AMENDMENT ACT, 2022**

In terms of section 66 of General Laws (Anti-Money Laundering and Combating Terrorism Financing) Amendment Act, 2022 (Act No. 22 of 2022), herein referred to as “the Amendment Act”, I hereby determine-

- (a) the date of publication of this Proclamation in the *Gazette*, as the date on which sections 9, 10, 16, 18 to 55, 59 and 62 to 65 of the Amendment Act, take effect; and
- (b) 1 April 2023, as the date on which-
  - (i) sections 1, 3, 4, 5, 8, 11 to 15, 17, 56, 57, 58, 60 and 61 of the Amendment Act, take effect;
  - (ii) section 2 of the Amendment Act takes effect, except subsection (1H) of section 6 of the Trust Property Control Act, 1988, as inserted by section 2 of the Amendment Act; and
  - (iii) section 6 of the Amendment Act takes effect, except section 11A(1)(c), (2) and (3) of the Trust Property Control Act, 1988, as inserted by section 6 of the Amendment Act.

  - (iii) artikel 6 van die Wysigingswet in werking tree, behalwe artikel 11A(1)(c), (2) en (3) van die Wet op die Beheer van Trustgoed, 1988, soos deur artikel 6 van die Wysigingswet ingevoeg.
