An Act to amend the Appropriation Act, 1981

[18th December, 1981

ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Appropriation (Amendment) Act, 1981, and shall be read as one with the Appropriation Act, 1981, hereinafter referred to as the principal Act.

Short title and commencement. Act No. 12 of 1981

(2) This Act shall be deemed to have come into operation on the 10th April, 1981.

Amendment of long title

2. The long title of the principal Act is amended by the deletion of "eight hundred and seventy million, one hundred and fifty-five thousand, two hundred and eleven kwacha" and the substitution therefor of "eight hundred and seventy million, one hundred and fifty-four thousand, three hundred and eleven kwacha".

Amendment of section 2

3. Section two of the principal Act is amended in subsection (1) by the deletion of "eight hundred and seventy million, one hundred and fifty-five thousand, two hundred and eleven kwacha" and the substitution therefor of "eight hundred and seventy million, one hundred and fifty-four thousand, three hundred and eleven kwacha".

Amendment of Schedule

- 4. The Schedule to the principal Act is amended—
 - (a) in Head No. 51/02, by the deletion of "2,633,300" and the substitution therefor of "2,683,300":
 - (b) in Head No. 95/01, by the deletion of "945,301", and the substitution therefor of "945,401";
 - (c) under recurrent expenditure, by the deletion of the sub-total "644,355,211" and the substitution therefor of "644,354,311";
 - (d) by the deletion of the total "870,155,211" and the substitution therefor of "870,154,311".
