ENACTED by the Parliament of Zambia.

1. (1) This Act may be cited as the Income Tax (Amendment) (No. 2) Act, 1982, and shall be read as one with the Income Tax Act, hereinafter referred to as the principal Act.

(2) This Act shall be deemed to have come into operation on the 4th December, 1979.

2. The Second Schedule to the principal Act is amended by the addition, immediately after paragraph 2A, of the following new paragraph:

2B. There shall be exempt from tax the Special Allowance paid to—
