An Act to amend the Liquor Licensing Act

ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Liquor Licensing (Amendment) Act, 1983, and shall be read as one with the Liquor Licensing Act, hereinafter referred to as the principal Act.

Short title and commencement. Cap. 429

- (2) This Act shall be deemed to have come into operation on the 29th January, 1983.
- 2. Section eighty-two of the principal Act is amended by the deletion of the full-stop and the substitution therefor of the following:

and exempt any person or class of persons from the application of any provision of this Act or from the payment of all or any part of the appropriate fee.

3. The Schedule to the principal Act is repealed and the Schedule set out in the Appendix hereto is substituted therefor.
