An Act to amend the Central Committee Members', Ministerial and Parliamentary Offices (Emoluments) Act, 1981

[27th December, 1985

ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Central Committee Members', Ministerial and Parliamentary Offices (Emoluments) (Amendment) Act, 1985, and shall be read as one with the Central Committee Members', Ministerial and Parliamentary Offices (Emoluments) Act, 1981, hereinafter referred to as the principal Act.

Short title and commencement. Act No. 3 of 1981

- (2) This Act shall be deemed to have come into operation on the 1st October, 1985.
- 2. Section one of the principal Act is amended by the deletion of subsection (2) and the substitution therefor of the following subsections:
 - (2) Sections six to eleven of this Act shall be deemed to have come into operation on the 1st December, 1980.
 - (3) The following provisions of this Act shall be deemed to have come into operation on the 1st October, 1985:
 - (a) paragraphs (a) and (b) of subsection (1) of section two:
 - (b) subsection (3) of section two;
 - (c) section three;
 - (d) subsections (1), (2) and (3) of section four; and
 - (e) paragraphs (a) and (b) of subsection (1) of section five.

Amendment of section 2

- 3. Subsection (3) of section two of the principal Act is amended—
 - (a) in sub-paragraph (i) by the deletion of "K12,800" and the substitution therefor of "K17,628"; and
 - (b) in sub-paragraph (ii) by the deletion of "K13,300" and the substitution therefor of "K22,000".

Amendment of section 3

4. Section three of the principal Act is amended in paragraph (a) by the deletion of "K480" and the substitution therefor of "K792".

Repeal and replacement of section 4

5. Section four of the principal Act is repealed and the following section replaced therefor:

Constituency and other allowances

- 4. (1) There shall be paid to an elected member of the National Assembly a constituency allowance calculated—
 - (a) in the case of a member returned by a constituency specified in Part I of the Second Schedule, at the annual rate of K2,400; and
 - (b) in the case of a member returned by a constituency specified in Part II of the Second Schedule, at the annual rate of K1,200.
 - (2) There shall be paid to a nominated member of the National Assembly, who is not a Member of the Central Committee, an allowance in lieu of a constituency allowance, calculated at the annual rate of K840.
 - (3) There shall be paid to a Member of the Central Committee of the Party an allowance in lieu of a constituency allowance, calculated at the annual rate of K1,120.
- (4) There shall be paid to a Member of the Central Committee of the Party, a Minister and Junior Minister—
 - (a) an electricity allowance at the annual rate of K720; and
 - (b) a water allowance at the annual rate of K480.

Amendment of section 5

- 6. Subsection (1) of section five is amended—
 - (a) in paragraph (a) by the deletion of "K8,400" and the substitution therefor of "K10,760"; and
 - (b) in paragraph (b) by the deletion of "K2,800" and the substitution therefor of "K5,200".

Repeal and replacement of First Schedule

7. The First Schedule to the principal Act is repealed and the First Schedule set out in Appendix I hereto is substituted therefor.

Repeal and replacement of Third Schedule

8. The Third Schedule to the principal Act is repealed and the Third Schedule set out in Appendix II hereto is substituted therefor.
