An Act to amend the Commission for Investigations Act

[19th September, 1986

ENACTED by the Parliament of Zambia.

Enactment

1. This Act may be cited as the Commission for Investigations (Amendment) Act, 1986, and shall be read as one with the Commission for Investigations Act, hereinafter referred to as the principal Act.

Short title

Cap. 183

2. Section *seven* of the principal Act is amended in subsection (1) by the deletion of "allegation of misconduct" and the substitution therefor of "allegation of maladministration, misconduct".

3. Section *nine* of the principal Act is amended—

(a) in subsection (2), by the deletion of "to conduct an investigation" and the substitution therefor of "to conduct, or may decide to discontinue, an investigation"; and

(b) in subsection (3), by the deletion of "or not to proceed further with any investigation" and the substitution therefor of "or decides to discontinue an investigation".

4. Section *eleven* of the principal Act is amended by the deletion of "any of its powers under this Act is likely to be frustrated" and the substitution therefor of "any investigation under this Act is likely to be frustrated or prejudiced".

5. Section *nineteen* of the principal Act is amended in subsection (1)—

(a) by the insertion, at the end of paragraph (c), of "or";
and

(b) by the insertion, immediately after paragraph (c), of the following new paragraph:

(d) wilfully disobey an order made under section eleven; .

Replacement of section 20

6. Section *twenty* of the principal Act is repealed and the following replaced therefor:

Submission of reports to President and National Assembly

20. The Commission shall—

(a) from time to time submit to the President a report of every enquiry which has been concluded containing a summary of evidence heard together with its conclusions and recommendations; and

(b) as soon as may be after the 31st December in each year submit to the National Assembly a report on its operations.

Amendment of Second Schedule

7. The Second Schedule to the principal Act is amended by the insertion at the end thereof of the I-G Form 10 set out in the Appendix hereto.
