An Act to provide for the payment of terminal gratuities to holders of certain specified offices upon their ceasing to hold office.

130th December, 1988

ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Specified Offices (Terminal Gratuities) Act, 1988.

Short title and commencement

Interpreta-

- (2) This Act shall be deemed to have come into force on the 1st day of February, 1988.
 - 2. In this Act, unless the context otherwise requires—

"earnings" means salary together with special allowance (if any);

"terminal gratuity" means terminal gratuity payable under this Act.

3. (1) Any person who holds any of the offices specified in the Schedule shall, upon his ceasing to hold that office, be entitled to be paid in a lump sum, a terminal gratuity equal to five times the annual earnings attached at the time he ceased to hold office, to the last such office held by him.

Payment of terminal gratuity to holders of certain specified offices

- (2) Terminal gratuity is in addition to any other gratuity or other benefit payable under any written law in respect of the office to which the terminal gratuity relates.
- (3) A person shall not be entitled to the payment of terminal gratuity who ceases to hold the relevant office as a result of disciplinary action taken against him.
- (4) Where a person has been paid terminal gratuity, he shall not be paid another terminal gratuity notwithstanding that he has served for a further period in an office specified in the Schedule

Minimum qualifying service

4. A person shall only be entitled to terminal gratuity if he has held one or more of the offices specified in the Schedulefor a total period not less than ten years:

Provided that a person shall be entitled to the payment of terminal gratuity if he has held any such office for a period of not less than five years and-

- (a) dies; or
- (b) ceases to hold that office on grounds of ill health certified in the prescribed manner; or
- (c) ceases to hold that office by reason of his being appointed, nominated or elected to another office other than an office specified in the Schedule.

Persons holding more than one office specified in Schedule

- 5. Where a person at the time he ceases to hold office. held at the same time more than one of the offices specified in the Schedule, the earnings in relation to which his terminal gratuity is to be calculated shall be—
 - (a) those attached to only one of those offices elected by him in writing and notified to the Secretary-General of the Party: or
 - (b) if the first-mentioned person has died without making any election, the earnings attached to the office determined in writing by the Secretary-General to be more favourable to the deceased person.

Terminal gratuity to be a charge on general revenues of \mathbf{the} Republic

Terminal gratuity shall be a charge on the general revenues of the Republic.

Terminal gratuity exempt from President to

Términal gratuity shall be exempt from any tax imposed on income or profits.

tax resolve doubts

- For the purposes of ascertaining whether or not terminal gratuity is payable in respect of any person, where any doubtarises as to-
 - (a) whether or not that person has ceased to hold any office specified in the Schedule; or
 - (b) whether or not a person has ceased to hold an office specified in the Schedule in any circumstances described in subsection (3) of section three;

the doubt shall be resolved by the President and his decision on the matter shall be final and shall not be questioned in any court.

Regulations

9. The President may, by statutory instrument, makeregulations for carrying into effect the provisions of this Act.
