### An Act to amend the Constitutional Offices (Emoluments) Act, 1985

[23rd July, 1990

ENACTED by the Parliament of Zambia.

1. (1) This Act may be cited as the Constitutional Offices (Emoluments) (Amendment) Act, 1990, and shall be read as one with the Constitutional Offices (Emoluments) Act, 1985, in this Act referred to as the principal Act.

(2) Paragraph (a) of section three shall be deemed to have come into operation on 1st September, 1989.

(3) Section two, paragraph (b) of section three and section four shall be deemed to have come into operation on 1st July, 1990.

2. Section three of the principal Act is amended by the deletion of paragraphs (a) and (b) and the substitution therefor of the following paragraphs:

(a) an electricity allowance at the annual rate of K9,888;

(b) a water allowance at the annual rate of K4,944;

3. The principal Act is amended by the repeal of the First Schedule thereto and the substitution therefor of—

- (a) the First Schedule set out in Appendix I to this Act for the period before 1st July, 1990;
- (b) the First Schedule set out in Appendix II of this Act with effect from 1st July, 1990.

4. The principal Act is amended by the revocation of the Second Schedule and the substitution therefor of the Second Schedule set out in Appendix III to this Act.
