## An Act to amend the Companies Act

[1st February, 1991

### ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Companies (Amendment) Act, 1990, and shall be read as one with the Companies Act, in this Act referred to as the principal Act.

Short title and commencement Cap. 686

- (2) This Act shall come into operation on 1st January, 1991.
- 2. The principal Act is amended by the repeal of the Second Schedule and the substitution therefor of the Second Schedule set out in the Appendix to this Act.
