## An Act to amend the Casino Act

[30th April, 1993

ENACTED by the Parliament of Zambia.

1. (1) This Act may be cited as the Casino (Amendment) Act, 1993 and shall be read as one with the Casino Act, in this Act referred to as the principal Act.

(2) This Act shall be deemed to have come into operation on the 30th January, 1993.

2. Section *three* of the principal Actis amended by the deletion A in subsection (7) of " five thousand kwacha " and the substitution of therefor of " twelve thousand five hundred kwacha ".

**3.** Section *ten* of the principal Act is amended by the deletion insubsection (1) of " twenty thousand kwacha " and the substitution therefor of " fifty thousand kwacha ".

4. Section *eleven* of the principal Act is amended by the deletion in subsection (2) of " one hundred thousand kwacha " and the substitution therefor of " two hundred and fifty thousand kwacha.".
