An Act to amend the Companies Act

[25th March, 1994

ENACTED by the Parliament of Zambia.

Enactment

1. (1) This Act may be cited as the Companies (Amendment) Act, 1994, and shall be read as one with the Companies Act, in this Act referred to as the principal Act.

Short title and commencement
Cap. 686

(2) This Act shall be deemed to have come into operation on the 29th January, 1994.

2. The principal Act is amended by the repeal of the Second Schedule and the substitution therefor of the Second Schedule set out in Appendix to this Act.

1.B. COMPANIES LIMITED BY GUARANTEE

Where the number of members is stated in the Articles of Association to be:

(1) Not exceeding 5 (minimum) fees. A further K10,000 for each additional or fraction of 5 members	K 12,500
(2) On conversion into a company limited by shares at K500,000 share capital	Nil
(3) Certificate of Incorporation of any company	10,000
(4) Registration of altered Memorandum of Association and order of court confirming the same	30,000
