An Act to amend the Constitutional Offices (Emoluments)
Act, 1993

ENACTED by the Parliament of Zambia.

Enactment

1. This Act may be cited as the Constitutional Offices (Emoluments) (Amendment) (No. 2) Act, 1995, and shall be read as one with the Constitutional Offices (Emoluments) Act, 1993.

Short title

2. The principal Act is amended by the repeal of section two and the substitution therefor of the following:

2. The holder of an office specified in the first column of the Schedule shall be paid as from the 1st of January, 1995, a salary at the annual rate prescribed for that office in the second column of the Schedule.
