An Act to amend the Petroleum Act

[28th April, 1995

ENACTED by the Parliament of Zambia.

1. This Act may be cited as the Petroleum (Amendment) Act, s 1995, and shall be read as one with the Petroleum Act, in this Act c referred to as the principal Act.

2. Section *two* of the principal Act is repealed and the following section is substituted therefor:

2. In this Act, unless the context otherwise requires—

- " crude petroleum " means any petroleum found in naturally formed liquid deposits and obtained as a raw material for the purpose of being refined into its many petroleum finished products or derivatives;
- " petroleum " means crude petroleum and petroleum derivatives;
- " petroleum derivatives " means any naturally occurring or manufactured petroleum hydrocarbon.

3. Section *three* of the principal Act is amended—

(a) in paragraph (c)—

- (i) by the insertion immediately after the word " quantity " of the words " and quality "; and
- (ii) by the insertion immediately after the word "quantities" of the words " and qualities ";

- (e) prescribing the safety and environmental requirements for the operation of all equipment, vessels, vehicles, trucks, and receptacles used in the processing, storage and sale of petroleum by establishing and enforcing the required codes for such, and licensing of the operators;
- (c) by the deletion of paragraph (d); and
- (d) by the renumbering of paragraphs "(e), (f), (g) and (h) " as "(f), (g), (h) and (i) ".

Amendment of section 4 4. Section *four* of the principal Act is amended in paragraph (b) by the insertion immediately after the word "ship " of a comma, and of the words " equipment, tank, vehicle, vessel and receptacle ".

Amendment of section 5 5. Section *five* of the principal Act is amended by the deletion of the words—

- (a) " one hundred k wacha " and the substitution therefor of the words " one hundred thousand penalty units "; and
- (b) " six months " and the substitution therefor of the words " ten years ".
